## Legislative Update

Week of June 1, 2020

As this week approached, there was uncertainty as to whether legislative activities would be impacted by the protests and civil unrest arising out of the death of Mr. George Floyd in Minneapolis. Notwithstanding citywide curfews and early legislative building closures, the General Assembly convened in-person and proceeded with short session business – albeit in the shadows of the current pandemic.

On Tuesday, the Senate unanimously approved Senate Bill 836, *State Operations/Increase Federal Funds Use.* The proposed measure would provide \$370 million towards state government continuity of operations. In addition, the Senate Select Committee on Prison Safety met to hear presentations on various prison safety technologies. Vendor presentations were provided by TextBehind, the Centinal Group, Tyler Technologies, and Guardian RFID. The meeting concluded with Prisons Commissioner Todd Ishee addressing questions from members regarding several issues, including staff vacancies and actions taken to reduce the spread of COVID-19 in facilities.

As reported last week, House Bill 1187, *Raise the Age Funding*, and House Bill 1063, *Fund VIPER Tower Hardware Upgrades*, were approved by the House and sent to the Senate. This week both bills floated through Appropriations and Rules committees, and were unanimously approved by the Senate Thursday. These measures will now be sent to Governor Cooper for his signature.

The Speaker of the House wrapped up the week by announcing a new bipartisan task force on Justice, Law Enforcement, and Community Relations in response to recent protests. It is expected to be a joint legislative task force with members from both chambers. The Speaker also indicated that members of the general public will be included and hold seats at the table. The task force will likely not begin its work until the short session concludes.
