#### CALL TO ORDER

Chairman Richard Allen called the February 20, 2014 Private Protective Services Board meeting to order at 9:00 a.m. Chairman Allen welcomed all guests. He explained that the change in credit hours from one (1) hour to two (2) hours for attending board meetings was still in the rule change process, therefore the current meeting would only be worth one (1) credit hour.

#### **GOOD OF THE ORDER:**

Attorney Jeff Gray explained the State Ethics Act, which addresses the ethics of public officials. This Act states specifically that if any Board Member has any conflict of interest, potential conflict of interest, or the appearance of a conflict, he or she should remove themselves from deliberation and vote on that matter and so state on the record.

Mr. Gregory Hatten, president of the NCAPI greeted the Board and all of the guests. Mr. Hatten reported that the annual election of NCAPI officers was held in January. He also stated that the Spring Conference is scheduled for March 18, 2014 and he requested that Staff be present.

#### **MINUTES:**

#### APPROVAL OF THE DECEMBER 12, 2013 MEETING MINUTES.

## MOTION BY MR. BOOTH TO ACCEPT THE MINUTES; SECONDED BY MR. BENSON; MOTION CARRIED.

Mr. MacRae thanked staff members for emailing the minutes to all board members.

#### **SCREENING COMMITTEE REPORT:**

Mr. Clark reported that the Screening Committee met on Wednesday, February 19, 2014 from 8:04a.m. to 10:51a.m. to review a total of 43 applications. (See report). The committee members were Mr. Clark, Mr. Benson, Mr. MacRae, Mr. Weaver, Mrs. Martin and Mr. Cobbler. Mr. Clark read the report for the record.

Mr. Stevens recused himself from #42 of the screening report and Mr. MacRae recused himself from #3.

Mr. Clark presented the following registration report for the period of December 11, 2013 to February 17, 2014. Total registrations 4,270; armed totals were 563 of which 191 were new and 281 were renewals, 2 duplicate, and 89 reissue/dual. There were a total of 98 Armed Armored Car, 35 of which were new, 62 were renewals, 1 reissue/dual. There were a total of 6 Armed Private Investigators, 3 of which were new, 3 were renewals; 4 new Private Investigator Associates, 3 renewals and 1 reissue/dual. Unarmed totals were 3,559 which included 1,074 new, 1,7309 renewals, 299 transfers, 15 duplicates and 441 reissue/dual. There were a total of 40 unarmed armored car, 12 of which were new. Total denials were 445 of which 81 were for cause and 364 for correctable reasons. There were 370 applications approved which were previously denied for a total of 815 denials reviewed.

#### MOTION BY MR. STEVENS TO ACCEPT THE SCREENING COMMITTEE REPORT AND THE REGISTRATION REPORT; SECONDED BY MR. WEAVER; MOTION CARRIED.

#### **GRIEVANCE COMMITTEE REPORT:**

Judge Burris reported the Grievance Committee met on Tuesday, February 18, 2014 from 8:06 a.m. until 12:06 p.m. and heard a total of 11 cases. The committee members were Judge Burris, Mr. Booth, Mr. Cook, Mr. Epley, Mr. Graham and Mr. Stevens. Judge Burris presented the attached report. (See attachment).

Mr. Clark recused himself from 2013-PPS-052. In reference to a few of the grievance cases heard by the committee, Mr. Stevens stressed the importance of good record keeping among industry members.

Mr. Cobbler asked if Mr. James DiBeniditto, brought before the grievance committee, was assessed a fine for practicing without first being licensed. Judge Burris explained that the committee found the violation to be a technical violation therefore Mr. DiBeniditto would not be penalized.

## MOTION BY MR. GRAHAM TO ACCEPT THE GRIEVANCE COMMITTEE REPORT; SECONDED BY MR. CLARK; MOTION CARRIED.

#### TRAINING & EDUCATION COMMITTEE:

Mr. Stevens advised that the Training & Education Committee met on Wednesday, February 19, 2014 from 8:00 a.m. until 9:00 a.m. The committee members were Mr. Stevens, Mr. Allen, Mr. Booth, Mr. Clark, Mr. Epley, Mr. MacRae and Mr. Weaver.

Presently we have 353 certified PPS unarmed guard trainers and 83 PPS certified armed guard trainers.

Mr. Stevens reported that trainer courses have been scheduled after the board meetings in an attempt to make courses geographically convenient. Mr. Stevens also reported that the committee discussed reinstating a trainer certification after a lapse without going back through the required training. This issue was brought to the board when a trainer asked that his certification be reinstated without having to go through training again. The board decided to deny the request. The committee also discussed the timing of unarmed and armed training. The issue of whether or not unarmed training would still need to be completed if armed training was completed first. The committee decided that feedback from the industry was needed to make an informed decision.

Mr. Epley reported that there were two (2) courses the subcommittee reviewed for approval: Executive Protection/Body Guard Training, twelve (12) hours, denied; Field Interview, twelve (12) hours, approved.

## MOTION BY MR. BOOTH TO ACCEPT THE SUBCOMMITTEES RECOMMENDATIONS; SECOND BY MR. WEAVER; MOTION CARRIED.

## MOTION BY MR. MACRAE TO ACCEPT THE TRAINING AND EDUCATION COMMITTEE REPORT; SECONDED BY MR. CLARK; MOTION CARRIED.

#### **GRIEVANCE COMMITTEE:**

Judge Burris discussed a complaint brought against licensee Kerry Graves. Mr. Graves allowed his brother, Mr. Kobie Graves, to conduct interviews with clients without being properly licensed to do so.

## MOTION BY MR. STEVENS TO ACCEPT THE COMMITTEE'S REPORT; SECONDED BY MR. WEAVER; MOTION CARRIED.

#### **SCREENING COMMITTEE:**

Mr. Clark stated that the screening report is final.

#### 74C REWRITE COMMITTEE

Mr. Epley reported the wording of House Bill 466 is correct and currently before the Senate. He will keep the board informed of its' progress.

#### **FINANCE REPORT:**

The Finance Committee meeting was not held. Mr. MacRae will continue his analysis of expenses. Mr. Weaver thanked Mr. MacRae for his work and CPA experience.

## MOTION BY MR. WEAVER TO ACCEPT THE FINANCE COMMITTEES REPORT; SECONDED BY MR. COOK; MOTION CARRIED.

#### **ETHICS COMMITTEE:**

Mr. Cook reported that the PPSB staff distributed the newsletter by email. He also reminded all industry members to file their SEI reports by April 15<sup>th</sup>.

#### **OLD BUSINESS:**

Due to dissatisfaction with the Crabtree Holiday Inn, the board discussed moving the meeting location. Mr. Wright informed the board that the best prospect is the Holiday Inn downtown. The hotel has facilities to hold the meeting and the board meeting dates are available.

#### MOTION BY MR. BOOTH TO NEGOTIATE RELOCATING BOARD MEETINGS TO ANOTHER FACILITY; SECONDED BY MR. COBBLER; MOTION CARRIED.

#### **NEW BUSINESS:**

Mr. Bonapart made the PPSB grant announcement summary. Mr. Bill Dover asked if the grant was no longer restricted to a 501C(3) business. Mr. Wright explained that the rule regarding 501C(3) and grants had not changed. Mr. Booth also explained to Mr. Dover that this rule was a Department of Justice rule, not a Private Protective Services rule.

Mr. Bonapart reported that an individual who applied for a grant under South Piedmont Community College did so without knowledge of the institution. As a result, funds were not issued.

The board discussed whether the industry was benefitting from the grants received to conduct training and if members of the industry were made aware of the training. Mr. Booth stated that Stanley Community College sent flyers to industry members and published a newspaper article.

Ms. Kathy Broom asked the board whether or not the training programs financed by the PPSB grants should be made available to all industry members since their contributions fund the

program. Mr. Booth responded that the industry was notified of the "Active Shooter" training at the last board meeting. Mr. Allen asked that staff make it a point to make industry members aware of the grant sponsored training and that they are notified when courses are being offered.

#### FINAL AGENCY DECISION

Attorney Jeff Gray removed himself as counsel to the Board to present the following cases.

The Board received the official record for the following cases:

Jose Monserrate Acosta 13 DOJ 15271 (attachment 3). Mr. Acosta was present. This case was heard by Administrative Law Judge Augustus B. Elkins II on October 7, 2013. This case involved the denial of Petitioner's unarmed guard registration based on the lack of good moral character and temperate habits as evidenced by a conviction of misdemeanor and felony possession of controlled substances.

Administrative Law Judge Augustus B. Elkins proposes that Petitioner be issued an unarmed guard registration.

#### MOTION BY JUDGE BURRIS TO UPHOLD JUDGE'S DECISION; SECONDED BY MR. BENSON; OPPOSED MR. WEAVER, MR. STEVENS AND MR. COBBLER; MOTION CARRIED.

Benjamin Lee Torain 13 DOJ 14220 (attachment 7). Mr. Torain was present. This case was heard by Administrative Law Judge Augustus B. Elkins II on October 7, 2013. This case involved the denial of Petitioner's armed guard registration based on lack of good moral character and temperate habits as evidenced by a conviction of felony Aggravated Assault in Philadelphia, PA.

Administrative Law Judge Augustus B. Elkins II proposed that the Board reverse its' decision and recommends that Petitioner be issued an unarmed guard registration.

### MOTION BY MR. STEVENS TO UPHOLD JUDGE'S DECISION; SECONDED BY MR. WEAVER; OPPOSED MR. BENSON; MOTION CARRIED.

Moses Lavan Balls 12 DOJ 7162 (attachment 4). Mr. Balls was not present. This case was heard as a Final Decision Dismissing Contested Case. It was ordered that Petitioner's appeal be dismissed without prejudice for failure to prosecute.

## MOTION BY JUDGE BURRIS TO DENY THE APPEAL; SECONDED BY MR. STEVENS; MOTION CARRIED.

Kenneth Levern Bradley 12 DOJ 8260 (attachment 5). Mr. Bradley was not present. This case was heard as a Final Decision Dismissing Contested Case. It was ordered that case be dismissed without prejudice for failure to prosecute on the part of petitioner.

### MOTION BY JUDGE BURRIS TO DENY THE APPEAL; SECONDED BY MR. STEVENS; MOTION CARRIED.

Cathy M. Brown 13 DOJ 14219 (attachment 6). Ms. Brown was not present. This case was heard by Administrative Law Judge Melissa Owens Lassiter on November 26, 2013. This case involved denial of Petitioner's unarmed guard renewal permit based on lack of good moral character and temperate habits as evidenced by a conviction of misdemeanor Larceny and Financial Card Fraud.

Administrative Law Judge Melissa Owens Lassiter recommended that the board deny Petitioner's renewal of her unarmed guard registration.

#### MOTION BY JUDGE BURRIS TO UPHOLD DENIAL; SECONDED BY MR. BENSON; MOTION CARRIED.

William John Cherpak 12 DOJ 7300 (attachment 8). Mr. Cherpak was not present. This case was heard by Administrative Law Judge Beecher R. Gray on September 25, 2012. This case involved denial of Petitioner's unarmed guard registration renewal based on lack of good moral character and temperate habits as evidenced by a conviction of misdemeanor Assault on a Female.

Administrative Law Judge Beecher R. Gray recommended that Petitioner be issued his unarmed guard registration renewal.

#### MOTION BY MR. WEAVER TO UPHOLD JUDGE'S DECISION AND ISSUE UNARMED GUARD REGISTRATION; SECONDED BY MR. COOK; MOTION CARRIED.

#### **DIRECTOR'S REPORT:**

Director Terry Wright read the report for the record. The current PPS budget as of January 31, 2014, has a balance of \$992,551.01; the Education Fund balance is \$63,949.75. As of January 31, 2014, the total registrations for PPS is 17,524, 1,816 licensees, and 588 certifications.

Mr. Wright reported that there have been a total of 2,341 various correspondences printed from the PPS database, 4,950 registration cards have been printed and a total of 5,582 applications received since the last Board meeting.

Mr. Wright informed the board of an email from Mr. George Fenton advising that after extensive negotiations with GL Solutions, the cost to include Armed Armored Car as an additional business process will cost \$10,000.00.

#### MOTION BY MR. BOOTH TO START A RULE CHANGE THAT GIVES APPLICANTS SIXTY (60) DAYS TO SUBMIT ALL REQUIRED PAPERWORK; SECONDED BY JUDGE BURRIS; MOTION CARRIED.

Mr. Wright will bring a list of correctable denials and for cause denials to the next board meeting for comparison. The board also discussed the opportunity to host the IAFTA conference in 2015. MOTION BY MR. WEAVER NOT TO PARTICIPATE IN THE CONFERENCE; SECONDED BY MR. BENSON; MOTION CARRIED.

Lastly, Mr. Wright reported that the issue regarding the refund policy would be tabled in order to discuss the number of refunds that need to be issued. Staff will report back at April meeting.

On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Mr. Manley in the amount of \$15,586.40 in twelve monthly installments of \$1,298.86 for registration violations. Received second payment on January 24, 2014.
- 2. Brian T. Lassiter/B K Lass Enterprises, Inc. On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Mr. Lassiter in the amount of \$3,610.80 in six monthly installments of \$601.80 for registration violations. Received second payment on February 7, 2014.
- 3. Felicia Myers/Absolute Contracting Services, Inc. On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Ms. Myers in the amount of \$6,976.80 to be paid in six monthly installments of \$1,162.80 for fifty-seven unarmed guard registration violations. Received second payment on February 14, 2014.
- 4. Robert Gary Brockway (Screening). On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Mr. Brockway in the amount of \$408.00 for a branch office violation. Paid in full.
- 5. Dennis Patric Pridgen/A-1 Security Services, LLC. On December 12, 2013 the Private Protective Services Board voted to enter into a consent agreement with mr. Pridgen in the amount of \$4,773.60 for registration violations. Payment was due January 19, 2014. Paid in full February 19, 2014.

6. Scott Smithers/Eye Spy Investigations. On December 12, 2013, the Private Protective Services Board voted to assess a civil penalty in the amount of \$1,000.00 for failing to offer a written report to a client. Under appeal.

#### **SCREENING COMMITTEE REPORT:**

Mr. Clark reported that the Screening Committee met on Wednesday, April 23, 2014 from 2:01 p.m. to 3:51 p.m. to review a total of 38 applications. (See report). The committee members were Mr. Clark, Mr. Benson, Mrs. Martin and Mr. Cobbler. Mr. Clark read the report for the record.

Mr. Clark presented the following registration report for the period of February 18, 2014 to April 21, 2014. Total registrations 3,575; armed totals were 410 of which 146 were new and 225 were renewals, 1 duplicate, and 38 reissue/dual. There were a total of 133 Armed Armored Car, 29 of which were new, 102 were renewals, 2 reissue/dual. There were a total of 14 Armed Private Investigators, 7 of which were new, 7 were renewals; 3 new Private Investigator Associates, 2 renewals and 1 reissue/dual. Unarmed totals were 2,997 which included 990 new, 1,785 renewals, 58 transfers, 24 duplicates and 140 reissue/dual. There were a total of 18 unarmed armored car, 13 of which were new. Total denials were 675 of which 150 were for cause and 525 for correctable reasons. There were 427 applications approved which were previously denied for a total of 1,102 denials reviewed.

This case involved the denial of Petitioner's armed guard registration renewal based on lack of food moral character and temperate habits as evidenced by a conviction of felony Grand Theft Motor Vehicle.

Administrative Law Judge Donald W. Overby proposes that Petitioner be issued an unarmed guard registration.

#### **DIRECTOR'S REPORT:**

Deputy Director Anthony Bonapart read the report for the record. The current PPS budget as of March 31, 2014, has a balance of \$928,965.00; the Education Fund balance is \$65,592.05. As of April 21, 2014, the total registrations for PPS is 17,887, 1,788 licensees, and 601 certifications.

Mr. Bonapart reported that there have been a total of 2,766 various correspondences printed from the PPS database, 4,950 registration cards have been printed and a total of 5,582 applications received since the last Board meeting.

#### **ATTORNEY'S REPORT:**

Attorney McDarris discussed the following:

#### I. CONSENT AGREEMENT, SETTLEMENT AGREEMENTS & CIVIL PENALTIES

- 1. Paul Manley Jr./Show Pros Entertainment Services of Charlotte, Inc. On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Mr. Manley in the amount of \$15,586.40 in twelve monthly installments for registration violations with the first payment due January 1, 2014. The fourth payment was received on April 2, 2014. (\$1,298.86).
- 2. Brian T. Lassiter/B K Lass Enterprises, Inc. On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Mr. Lassiter in the amount of \$3,610.80 in six monthly installments of \$601.80 for registration violations. The fourth payment was received on April 11, 2014.
- 3. Felicia Myers/Absolute Contracting Services, Inc. On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Ms. Myers in the amount of \$6,976.80 to be paid in six monthly installments of \$1,162.80 for fifty-seven unarmed guard registration violations with first payment due January 1, 2014. The fourth payment was received on April 1, 2014.
- 4. Scott Smithers/Eye Spy Investigations. On December 12, 2013, the Private Protective Services Board voted to suspend Mr. Smither's private investigator license for a period of ninety (90) days, but suspend the suspension if he provided his client a writeen report and then only assess a civil penalty in the amount of \$1,000.00 forfailing to offer a written report to a client. The licensee rejected the offer of settlement and requested an administrative hearing. A hearing was held in the Office of Administrative Hearings on February 25, 2014.

#### III. RULES

- 1. The rule changes to 12 NCAC 07D.0106, .0501, .0502, .0503, .0504 and .1302 were approved by the Rules Review Commission at its April 17, 2014 meeting. They are effective May 1, 2014.
- 2. At its October 24, 2013 meeting, the Board approved a proposed rule change to 12 NCAC 07D.0901(e) to delete the provision allowing firearms instructors certified by the Criminal Justice Education and Training Commission to pay only one-half the course fee amount to attend the required portion of the firearms trainer course. The G.S. 150B-19.1 Certification form for this rule change was filed and the Rules Review Commission certified it at its December 19, 2013 meeting. The Notice of Text was filed on January 10, 2014. The Public Hearing was held on February 25, 2014 at 2:00 p.m. at the Board's office. No one attended and no public comment was received. The Public comment Period ended April 14, 2014 and no comments –written or oral—were received.
- 3. Board staff recently discovered that there are no rules governing "authorized firearms" or "uniforms and equipment" in the recently adopted Unarmed Armored Car Service Guards and Armed Armored Car Service Guard administrative rules (i.e. 12 NCAC 07D Section .1400 and 12 NCAC 07D Section .1500). Arguably, with the new categories, an individual or company could contend the rules governing unarmed and armed security guards in these areas 12 NCAC 07D.0809 and 12 NCAC 07D .0105 do not apply to unarmed and armed armored car service guards. It was recommended by staff at the Board's February

20, 2014 meeting that these rules be amended to correct these deficiencies. The Board voted to accept the recommendation. If acceptable, a motion to proceed with the rulemaking process is in order.

4. During discussions regarding implementation of the Board's new on-line application and renewal program, staff also realized that there is no rule regulating the length of time between submission of an application for a license, registration for renewal of a license or registration and the completion of the application process.

The lack of a "cut-off" for the application process will prevent closure of the file in the new system and such application s will otherwise remain open indefinitely. At the Board's February 20, 2014 meeting, Director Wright recommended a rule adoption to address this issue.

5. As previously reported during the 2012 Session of the Legislature, the Joint Legislative Administrative Oversight Committee replaced the Joint Select Regulatory Reform Committee. This Committee has oversight over the study oby the Program Evaluation Division (PED) of the structure, organization and operation of all occupational licensing boards in the State as required by Section 10(a) of S.L. 2013-413. At its' December 3, 2013 meeting, the Director of the PED reported to the committee on the status of this study.

It is anticipated that the PED will begin the process of evaluation of the Board in May, 2014, which will commence with a visit to the office and an interview of staff. Its final report on all occupational and professional licensing boards is due to the Administrative Procedures Oversight committee by December 31, 2014.

6. During the 2013 Session of the legislature, the General Assembly passed S.L. 2013-413 (still commonly referred to as "House Bill 74) which amended Chapter 150B of the General Statutes to add a new section, N.C.G.S. § 150B-21.3A, required a periodic review and expiration of existing rules. The review of <u>all</u> rules for <u>all</u> State agencies is anticipated to be a five (5) year process. Administrative rules governing the review process are being adopted by the Rules Review Commission and a chart of the review schedule has recently been released. The Board's rules are scheduled for review in August, 2018.

#### IV. PENDING CASES

As previously reported, the Plaintiff has refiled the civil action against Board Investigator Sarah Conner, the Board, the city of Charlotte, the Charlotte-Mecklenburg Police Department and various officers of the Charlotte-Mecklenburg PD in *Kelly v. Conner, et al.*, No. 3:13-CV-636—WDNC. Mr. Kelly was unlicensed as a security guard business and unregistered, but performing security guard and patrol services. He is also a convicted felon. He was arrested and charged with, among other violations, violating Chapter 74C.

The Plaintiff's Attorney has had difficulty serving all parties, and one party failed to answer; this party has now been defaulted and there is "joinder of parties" under the Federal Rules of Civil Procedure. The time for discovery and the filing of motions began to run on April 9, 2014. Attorney Gray has begun preparing, and will soon file a Motion to Dismiss on behalf of the Board. The Attorney General's Office is again representing Ms. Conner.

#### V. MISCELLANEOUS

At the Board's February 20, 2014 meeting, the board requested that Attorney Gray research and then prepare a Memorandum explaining the difference between employees and independent contractors, or "W-2 employees" <u>vs.</u> "1099 employees."

Alejandro Maurent 13 DOJ 17940(attachment 4 to Attorney's Report). Mr. Maurent was present. This case was heard by Administrative Law Judge Augustus B. Elkins II on December 9, 2013. This case involved the denial of Petitioner's armed guard registration renewal based on lack of good moral character and temperate habits as evidenced by a conviction of felony Possession of a Controlled Substance in the State of Florida in 1998.

Administrative Law Judge Augustus B. Elkins, II, proposes that Petitioner be granted an armed guard registration.

#### MOTION BY MR. CLARK TO UPHOLD JUDGE'S DECISION AND GRANT AN ARMED GUARD REGISTRATION; SECONDED BY MR. WEAVER; MOTION CARRIED.

#### **DIRECTOR'S REPORT:**

Director Terry Wright read the report for the record. The current PPS budget as of May 31, 2014, has a balance of \$1,003,965.70; the Education Fund balance is \$66,736.90. As of June 23, 2014, the total registrations for PPS is 17,799, 1,731 licensees, and 600 certifications.

Mr. Wright reported that there have been a total of 3,089 various correspondences printed from the PPS database, 3,681 registration cards have been printed and a total of 5,663 applications received since the last Board meeting.

#### **ATTORNEY'S REPORT:**

Attorney Gray discussed the following:

#### I. CONSENT AGREEMENT, SETTLEMENT AGREEMENTS & CIVIL PENALTIES

- 1. Paul Manley Jr. /Show Pros Entertainment Services of Charlotte, Inc. On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Mr. Manley in the amount of \$15,586.40 in twelve monthly installments for registration violations with the first payment due January 1, 2014. The sixth payment was received on May 23, 2014. (\$1,298.86).
- 2. Brian T. Lassiter/B K Lass Enterprises, Inc. On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Mr. Lassiter in the amount of \$3,610.80 in six monthly installments of \$601.80 for registration violations. Paid in full.
- 3. Felicia Myers/Absolute Contracting Services, Inc. On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Ms. Myers in the amount of \$6,976.80 to be paid in six monthly installments of \$1,162.80 for fifty-seven unarmed guard registration violations with first payment due January 1, 2014. Paid in full.
- 4. Scott Smithers/Eye Spy Investigations. On December 12, 2013, the Private Protective Services Board voted to suspend Mr. Smithers' private investigator license for a period of ninety (90) days, but suspend the suspension if he provided his client a written report and then only assess a civil penalty in the amount of \$1,000.00 for failing to offer a written report to a client. The licensee rejected the offer of settlement and requested an

administrative hearing. A hearing was held in the Office of Administrative Hearings on February 25, 2014. The board is awaiting the Proposed Final Decision from the Administrative Law Judge.

5. Cynthia Louise Breeden/BCSi Security, Inc. On April 24, 2014 the Board voted to enter into a consent agreement with Ms. Breeden in the amount of \$938.40 for registration and branch office violations. Paid in full.

#### III. RULES

- 1. The rule changes to 12 NCAC 07D.0106, .0501, .0502, .0503, .0504 and .1302 were approved by the Rules Review Commission at its April 17, 2014 meeting. They are effective May 1, 2014.
- 2. The rule change to 12 NCAC 07D.0901(e) to delete the provision allowing firearms instructors certified by the Criminal Justice Education and Training Commission to pay only one-half the course fee amount to attend the required portion of the firearms trainer course was approved by the Rules Review Commission at its June 18, 2014 meeting. It is effective July 1, 2014.
- 3. Board staff recently discovered that there are no rules governing "authorized firearms" or "uniforms and equipment" in the recently adopted Unarmed Armored Car Service Guards and Armed Armored Car Service Guard administrative rules (i.e. 12 NCAC 07D Section .1400 and 12 NCAC 07D Section .1500). The G.S.

150B-19.1 Certification form for these rule changes were filed May 14, 2014 and the Rules Review Commission certified amended 12 NCAC 07D.0809 and 12 NCAC 07D and new 12 NCAC 07D.1408 and 12 NCAC 07D.1508 at its June 18, 2014 meeting. Mr. Gray was present for the filing of the Notice of Text.

4. During discussions regarding implementation of the Board's new on-line application and renewal program, staff also realized that there is no rule regulating the length of time between submission of an application for a license, registration for renewal of a license or registration and the completion of the application process.

The lack of a "cut-off" for the application process will prevent closure of the file in the new system and such application s will otherwise remain open indefinitely. G.S. 150B-19.1 Certification form for this rule change was filed on May 14, 2014 and the Rules Review Commission certified amended 12 NCAC 07D.0116 at its June 18, 2014 meeting.

- 5. At its April 24, 2014 meeting, the Board approved a change requested by staff to drop the use of the term "dual" and begin using the term "transfer" when referring to an unarmed security guard registered with more than one company. This change in designation will require a rule change. If acceptable, a motion to proceed with the rule making process is in order.
- 6. Mr. Gray has previously reported that during the 2012 Session of the Legislature, the Joint Legislative Administrative Oversight Committee replaced the Joint Select Regulatory Reform Committee. This Committee has oversight over the study by the Program Evaluation Division (PED) of the structure, organization and operation of all occupational licensing boards in the State and the feasibility of a single "umbrella" agency as required by Section 10(a) of S.L. 2013-413. Mr. Gray has attended the meetings of this Committee. At its June 23, 2014 meeting, the Principal Evaluator of the PED (in lieu of the Director) reported to the Committee on the status of this study.

The PED began the process of evaluation of boards in May, 2014. Only four (4) boards were visited and the staffs interviewed. The remainder will be evaluated through a "questionnaire" currently being developed. Its final report on all occupational and professional licensing boards is due to the Administrative Procedures Oversight committee by December 31, 2014.

During the 2013 Session of the legislature, the General Assembly passed S.L. 2013-413 (still commonly referred to as "House Bill 74") which amended Chapter 150B of the General Statutes to add a new section, N.C.G.S. § 150B-21.3A, requiring a periodic review and expiration of existing rules. (See, October 24, 2013 Attorney's Report.) The review of <u>all</u> rules for <u>all</u> State agencies is

anticipated to be a five (5) year process. Administrative rules governing the review process have been adopted by the Rules Review Commission and a chart of the review schedule has been released. The Board's rules are scheduled for review in August, 2018. A flow chart detailing the review process was attached in the April 24, 2014 Attorney's Report.

#### IV. PENDING CASES

 At the March, 2013 Board meeting, the board was informed by deputies with the Brunswick County Sheriff's Office that Bill Haglar of Oak Island, NC was under criminal investigation for performing private investigation services and holding himself out as a private investigator without a license. Mr. Haglar has received five (5) C&D letters from the Board over a six (6) year period for the same activities. As a result, and upon motion of the Board, on March 25, 2013 Mr. Gray filed a Complaint for Injunctive Relief on behalf of the Board in *NC PPSB v. William John Haglar*, 13 CVS 004090 – Wake County Mr. Haglar file an Answer, *pro se*, to the Complaint.

In early June Mr. Gray learned from the Sheriff's Office that Mr. Haglar had posted LinkedIn and other social network postings online holding himself out as a PI after the lawsuit was filed. Mr. Gray filed a motion on June 13<sup>th</sup> and obtained an Order Granting Preliminary Injunction on June 24, 2013 in Wake County Superior Court to enjoin Mr. Haglar's activities.

The Brunswick County Sheriff's Office arrested and criminally charged Mr. Haglar for violation of the Board's law and rules as well as felony obtaining property by false pretenses. He is free on \$10,000 secured bond awaiting trial.

On August 20, 2013, Mr. Haglar represented himself to Heather Howle, Assistant Director of the Brunswick County Senior Center, as a private investigator. He also gave Ms. Howle a business card with his name and "Investigative Services" under it and the logo of "Haglar Investigative Services." He admitted to the investigating officer he had done so and that he is unlicensed. I obtained an Affidavit from Ms. Howle and Sgt. M.L. Williams of the Southport Police Department, and then filed a Motion for Order to Show Cause on September 23, 2013. Mr. Haglar appeared, represented by counsel, and the Court allowed the matter to be continued since his attorney had not been retained except for that appearance.

The matter was re-calendared for hearing on Thursday, October 31<sup>st</sup>. The presiding Judge found Mr. Haglar in both civil and criminal contempt of the June 24<sup>th</sup> Order. He was jailed in the Wake County Detention Center for 48 hours.

This matter was called for trial (for the second time) for the June 9, 2014 Trial Calendar. The Defendant signed a Consent Order agreeing not to further engage in the private protective services business unless licensed by the Board. Mr. Gray is awaiting return of the signed Order from the presiding Judge.

2. As previously reported, the Plaintiff has refiled the civil action against Board Investigator Sarah Conner, the Board, the City of Charlotte, the Charlotte-Mecklenburg Police Department and various officers of the Charlotte-Mecklenburg PD in *Kelly v. Conner, et al.*, No.3:13-CV-636—WDNC. Mr. Kelly was unlicensed as a security guard business and unregistered, but performing security guard and patrol services. He is also a convicted felon. He was arrested and charged with, among other violations, violating Chapter 74C.

The Plaintiff's attorney had difficulty serving all parties, and one party failed to answer; this party has now been defaulted and there is "joinder of parties" under Federal Rules of Civil Procedure. The time for discovery and the filing of motions began to run on April 9, 2014. The Board received Plaintiff's First Set of Interrogatories and Request for Production of Documents on May 29, 2014. Mr. Gray and staff have begun preparing responses to Plaintiff's discovery requests but will not make the initial deadline of June 30<sup>th</sup>. The Plaintiff's attorney has stipulated to a 30-day extension of time. Once the discovery responses are served, Mr. Gray will then file a Motion to Dismiss on behalf of the Board. The Attorney General's Office is again representing Ms. Conner.

#### V. MISCELLANEOUS

At the Board's April 24, 2014 meeting, the Board requested that Mr. Gray prepare a Memorandum regarding the statute and rules governing armed private investigators. A copy of the memorandum was attached to the Attorney's Report.

## MOTION BY MR. CLARK TO ACCEPT ATTORNEY'S REPORT; SECONDED BY MR. STEVENS; MOTION CARRIED.

The Board reviewed a draft of the resolution for Helen Parker.

## MOTION BY MR. STEVENS TO ACCEPT THE RESOLUTION; SECONDED BY JUDGE BURRIS; MOTION CARRIED.

#### **<u>PUBLIC COMMENT</u>**:

Mr. John Taylor sent a memo to the Board requesting that they increase the number of reciprocal agreements for five (5) additional states, Maryland, New Jersey, Pennsylvania, Washington D.C. and West Virginia. Mr. Clark suggested that before the Board reviews his request that he check with these states about their reciprocal agreements. He also advised that if he needed further guidance to contact staff or Mr. Clark himself who would act as liaison for the Board.

Mr. Gary Pastor addressed the Board to ask if it was possible to change the firearms renewal period from one year to two years. Mr. Clark replied stating that anyone holding a firearms

certification should be required to requalify at the range as a matter of safety to the public. Chairman Allen asked staff to explore the pros and cons of Mr. Pastor's suggestion and report back to the Board.

Judge Burris recognized Chairman Allen and Mrs. Denise Martin who will not be returning as Board members.

Mr. Gray advised the Board that his contract was up for renewal.

#### CALL TO ORDER

#### **SCREENING COMMITTEE REPORT:**

Mr. Clark reported that the Screening Committee met on Wednesday, August 20, 2014 from 2:00 p.m. to 5:24 p.m. to review a total of 49 applications. (See report). The committee members were Mr. Clark, Mr. Weaver, Mr. Cobbler, Mr. MacRae and Mr. Benson. Mr. Clark read the report for the record.

Mr. Weaver recused himself from #5, #26 and #32 of the screening report. Mr. Clark discussed the business plan submitted by Black Diamond regarding whether or not a license is necessary to carry a firearm during transportation.

On July 9, 2014, Mr. Daniel Newell submitted a business plan to the Board outlining his new company. He stated that the principle service he will offer to citizens is transportation. His main area of operation will be Charlotte. He stated that he will provide limousine services to a wide variety of clients from NBA stars, NFL players, celebrities and NASCAR. He stated that he would like to provide armed drivers at an additional cost to his customers. He explained that he would only hire personnel that have attended personal protection classes.

The committee discussed the business plan with Mr. Newell. The Board determined that the company would need to apply for the private investigator license to offer those services.

Mr. Clark also discussed the letter submitted to the Board by Mr. Leonard Wolf in reference to the requirements to obtain a guard dog profession license. Due to the fact that this might require a change in the statutes, the matter was referred to the Law and Rules Committee.

Mr. Clark presented the following registration report for the period of June 25, 2014 to August 18, 2014. Total registrations 3,874; armed totals were 565 of which 159 were new and 263 were renewals, and 143 reissue/dual. There were a total of 127 Armed Armored Car, 55 of which were new, 69 were renewals, 1 duplicate and 2 reissue/dual. There were a total of 11 Armed Private Investigators, 5 were new and 6 renewals; 2 new Private Investigator Associates, 5 renewals and

1 reissue/dual. Unarmed totals were 3,149 which included 1,264 new, 1,703 renewals, 174 transfers, 4 duplicates and 4 reissue/dual. There were a total of 14 unarmed armored car, 10 of which were new. Total denials were 827 of which 184 were for cause and 643 for correctable reasons. There were 716 applications approved which were previously denied for a total of 1.543 denials reviewed.

### LAW AND RULES COMMITTEE

Mr. Epley related that he would like to spend time with Mr. Gray to review the recent House Bill. He would like to discuss and develop a plan of action to submit changes of PPSB statutes to the legislature. Mr. Epley would also like to address reducing the members of the Law and Rules Committee. Mr. Weaver responded that those are good issues and suggested tabling the discussion until the three day meeting in October. The three-day meeting is scheduled for October 21-23, 2014 which will provide more time to discuss various issues.

#### FINANCE REPORT:

Mr. MacRae reported that he distributed the financial activity sheet to all Board members. He related that he spoke with Mr. Wright and Mr. Bonapart about an expense for temporary services. We use temporary employees that are provided by the temp agency. During this period the cost for temp services increases substantially. Mr. Wright will be researching that expense to find out why the increase occurred.

#### **OLD BUSINESS:**

Mr. Weaver discussed the location of the 2015 Board meetings. All meetings are scheduled for Raleigh except the February 2015 Board meeting dates. Mr. Benson reiterated his position that all Board meetings should be held in Raleigh. It is more cost effective to have all meetings in Raleigh. He thanked Mr. Bonapart for providing data on attendance at previous Board meetings showing that attendance is high in Raleigh. Mr. MacRae reviewed the attendance data provided to the Board. The data shows only one person attending Board meetings from specific counties. He stated that until there are stronger attendance numbers in other locations, the meetings should stay in Raleigh. Mr. Foster stated that we need data on where the bulk of our licenses are located in the state. Data showing where our licenses reside in the state will help us make better decisions. Mr. Booth agreed and stated we need to know where our licenses are from. The last two years we are getting only one representative from specific counties. Mr. Cook stated that the board should try to cut expenses and keep all meetings in Raleigh.

This case involved the denial of Petitioner's unarmed guard registration renewal based on lack of good moral character and temperate habits as evidenced by a conviction of misdemeanor Assault on a Female on February 16, 2010.

Administrative Law Judge Melissa Owens Lassiter proposes that Respondent issue an unarmed guard permit to Petitioner.

#### **DIRECTOR'S REPORT:**

Deputy Director Anthony Bonapart read the report for the record. The current PPS budget as of July 31, 2014, has a balance of \$1,069,613.87; the Education Fund balance is \$68,335.35. As of August 18, 2014, the total registrations for PPS is 18,514, 1,709 licensees, and 588 certifications.

Mr. Bonapart reported that there have been a total of 2,891 various correspondences printed from the PPS database, 4361 registration cards have been printed and a total of 5,032 applications received since the last Board meeting.

# MOTION BY MR. BOOTH TO ACCEPT THE DIRECTOR'S REPORT; SECONDED BY MR. COOK; MOTION CARRIED.

Mr. Wright advised the Board that the online system is scheduled to go live in the Winter of 2014.

### **ATTORNEY'S REPORT:**

Attorney Gray discussed the following:

#### I. CONSENT AGREEMENT, SETTLEMENT AGREEMENTS & CIVIL PENALTIES

- 1. Paul Manley Jr. /Show Pros Entertainment Services of Charlotte, Inc. On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Mr. Manley in the amount of \$15,586.40 in twelve monthly installments for registration violations with the first payment due January 1, 2014. The eighth payment was received on August 1, 2014. (\$1,298.86).
- 2. Scott Smithers/Eye Spy Investigations. On December 12, 2013, the Private Protective Services Board voted to suspend Mr. Smithers' private investigator license for a period of ninety (90) days, but suspend the suspension if he provided his client a written report and then only assess a civil penalty in the amount of \$1,000.00 for failing to offer a written report to a client. The licensee rejected the offer of settlement and requested an administrative hearing. A hearing was held in the Office of Administrative Hearings on February 25, 2014. The Amended Proposal for Decision and the Official Record have been received and the Final Agency Decision hearing is scheduled for the Board's October 23<sup>rd</sup> meeting.

### III. RULES

- 1. The rule change to 12 NCAC 07D.0901(e) to delete the provision allowing firearms instructors certified by the Criminal Justice Education and Training Commission to pay only one-half the course fee amount to attend the required portion of the firearms trainer course was approved by the Rules Review Commission at its June 18, 2014 meeting. It became effective July 1, 2014.
- 2. Board staff recently discovered that there are no rules governing "authorized firearms" or "uniforms and equipment" in the recently adopted Unarmed Armored Car Service Guards and Armed Armored Car Service Guard administrative rules (i.e. 12 NCAC 07D Section .1400 and 12 NCAC 07D Section .1500). The G.S. 150B-19.1 Certification form for these rule changes were filed May 14, 2014 and the Rules Review Commission certified amended 12 NCAC 07D.0809 and 12 NCAC 07D and new 12 NCAC 07D.1408 and 12 NCAC 07D.1508 at its June 18, 2014 meeting. Attorney Gray filed the Notice of Text for these rules on July 8, 2014. The Public Hearing will be held at the Board's office, 4901 Glenwood Avenue, Suite 200, Raleigh, North Carolina 27612 on August 27, 2014 at 2:00 p.m., and the Public Comment Period ends September 30, 2014.
- 3. During discussions regarding implementation of the Board's new on-line application and renewal program, staff also realized that there is no rule regulating the length of time between submission of an application for a license, registration for renewal of a license or registration and the completion of the application process.

The lack of a "cut-off" for the application process will prevent closure of the file in the new system and such application s will otherwise remain open indefinitely. The G.S. 150B-19.1 Certification form for this rule change was filed on May 14, 2014 and the Rules Review Commission certified amended 12 NCAC 07D.0116 at its June 18, 2014 meeting. Attorney Gray filed the Notice of Text for this rule amendment on July 8, 2014. The Public Hearing will be held at the Board's office, 4901 Glenwood Avenue, Suite 200, Raleigh, North Carolina 27612 at 2:00 p.m., and the Public Comment Period ends September 30, 2014.

4. Mr. Gray has previously reported that during the 2012 Session of the Legislature, the Joint Legislative Administrative Oversight Committee replaced the Joint Select Regulatory Reform Committee. This Committee has oversight over the study by the Program Evaluation Division (PED) of the structure, organization and operation of all occupational licensing boards in the State and the feasibility of a single "umbrella" agency as required by Section 10(a) of S.L. 2013-413. Mr. Gray has attended the meetings of this Committee. At its June 23, 2014 meeting, the Principal Evaluator of the PED (in lieu of the Director) reported to the Committee on the status of this study.

The PED began the process of evaluation of boards in May, 2014. Only four (4) boards were visited and the staffs interviewed. The remainder will be evaluated through a "questionnaire" which all boards, including the PPSB, received on July 9<sup>th</sup>. It contained 58 questions, the majority of which were related to financial issues. The responses were submitted by the deadline of July 31<sup>st</sup>. The PED's final report on all occupational and professional licensing boards is due to the Administrative Procedures Oversight Committee by December 31, 2014.

5. During the 2013 Session of the legislature, the General Assembly passed S.L. 2013-413 (still commonly referred to as "House Bill 74") which amended Chapter 150B of the General Statutes to add a new section, N.C.G.S. § 150B-21.3A, requiring a periodic review and expiration of existing rules. (See, October 24, 2013 Attorney's Report.) The review of <u>all</u> rules for <u>all</u> State agencies is anticipated to be a five (5) year process. Administrative rules governing the review process have been adopted by the Rules Review Commission and a chart of the review schedule has been released. The Board's rules are scheduled for review in August, 2018. A flow chart detailing the review process was attached in the April 24, 2014 Attorney's Report.

#### **IV. LEGISLATION**

- The General Assembly has yet to adjourn for its 2013-2014 Biennial Session. To date, there has been no further movement of House Bill 466, "Amend Private Protective Services Act/Fees," since passage by the House and referral to the Senate Judiciary I Committee on April 29, 2013.
- 2. As you are aware, a provision in the State Budget (Senate Bill 784) transferred the Private Protective Services Board and the Alarms Systems Licensing Board to the Department of Public Safety. In addition to the transfer, the provision changes the designated representative to the Secretary of Public Safety and gives the Governor the Attorney General's two (2) appointments.

Staff has already had two initial meetings with the head of financial and human resources for DPS.

#### V. PENDING CASES

 As previously reported, the Plaintiff has refiled the civil action against Board Investigator Sarah Conner, the Board, the City of Charlotte, the Charlotte-Mecklenburg Police Department and various officers of the Charlotte-Mecklenburg PD in *Kelly v. Conner, et al.*, No. 3:13-CV-636 – WDNC. Mr. Kelly was unlicensed as a security guard business and unregistered, but performing security guard and patrol services. He is also a convicted felon. He was arrested and charged with, among other violations, violating Chapter 74C.

The Plaintiff's attorney had difficulty serving all parties, and one party failed to answer; this party has now been defaulted and there is "joinder of parties" under the Federal Rules of Civil Procedure. The time for discovery and the filing of motions began to run on April 9, 2014. The board received Plaintiff's First Set of Interrogatories and Request for Production of Documents on May 2, 2014. Staff and Attorney Gray have begun preparing responses to Plaintiff's discovery requests but will not make the initial deadline of June 30<sup>th</sup>. The Plaintiff's attorney stipulated to a 30 day extension of time and the Board's discovery responses were served on August 1<sup>st</sup>. Attorney Gray will file a Motion to Dismiss on behalf of the board. The Attorney General's Office is again representing Ms. Conner.

#### VI. MISCELLANEOUS

 On July 10, 2014 Governor Pat McCrory signed SB 741 (S.L. 2014-67), "An Act to Enhance the Effectiveness of the Occupational Licensing of Military Service Members." This Act amends the recently enacted amendments to Chapter 93B of the General Statues regarding military-trained applicants and applicants who are spouses of active duty military. (Note: The Board's amendments to its administrative rules to effectuate these requirements were effective October 1, 2013.)

The Act deleted the provision in N.C.G.S 93B-15.1(a)(1) that the applicant's experience is a determination to be made by the Board. It also requires the Board to notify the military-trained applicant within 30 days following receipt of an application whether the applicant's military training and experience satisfies the requirements for licensure that are satisfied by military training and experience and publish it on the Board's website and the website of the North Carolina Division of Veterans Affairs. The Board must further contact training offices at military installations <u>or</u> any other federal offices that provide information on military occupational specialties and training for the purpose of acquiring information necessary for determining the applicability and correlation of military training and experience to the criteria and requirements for licensure, certification or registration.

No later than September 1, 2014, each occupational licensing board shall submit a report to the co-chairs of the Legislative Research Commission Study Committee on Civilian Credit for Military Training and State Adjutant Selection Criteria with the status of the required document and the results of their consultation with military training officials as required by the Act.

Many questions have been raised by this new legislation and Attorney Gray will be working with staff, as well as the attorneys and staff for similar occupational licensing boards such as the Criminal Justice Education and Training Standards commission, the Sheriff's Education and Training Standards Commission and the Alarm Systems Licensing Board, to ensure an efficient, economic and practical implementation of the Act.

Board staff have already made initial contact with each of the five branches of the military.

2. At the Board's April 24, 2014 meeting, the Board requested that Mr. Gray prepare a Memorandum regarding virtual office and the Board's branch office requirements.

Attorney Charles McNair removed himself as counsel to the Board to present the following cases.

The Board received the official record for the following case:

Alvin Thomas Bennett 14 DOJ 1061 (attachment 3). Mr. Bennett was not present. This case was heard by Administrative Law Judge Craig Croom on March 28, 2014. This case involved the suspension of Petitioner's firearms permits based on lack of good moral character and temperate habits as evidenced by a charge of Larceny after Breaking and Entering, Felony Breaking and Entering and Felony Possession of Stolen Property in Mecklenburg County, North Carolina for offenses that occurred on December 30, 2013.

Administrative Law Judge Craig Croom proposes that Petitioner's armed registration permits be summarily suspended.

# MOTION BY MR. BOOTH TO UPHOLD JUDGE'S DECISION; SECONDED BY MR. COOK; MOTION CARRIED.

Scott Eric Smithers 14 DOJ 00728 (attachment 5). Mr. Smithers was not present. This case was heard by Administrative Law Judge Craig Croom on February 25, 2014. This case involved the suspension of the Petitioner's private investigator license based on lack of good moral character and temperate habits as evidenced by Petitioner willfully failing to render to a client services as agreed between the parties and for which compensation has been paid or tendered in accordance with the agreement of the parties, failed to offer a report to a client within thirty (30) days of the client's written request after the client has paid for services rendered, and divulged to any person, except as required by law, any information acquired by the private investigator except at the direction of the employer or client for whom the information was obtained.

Administrative Law Judge Craig Croom proposed that Petitioner's license be suspended for a period of six (6) months.

# MOTION BY MR. BOOTH TO UPHOLD JUDGE'S DECISION; SECONDED BY MR. COOK; MOTION CARRIED.

### **DIRECTOR'S REPORT:**

Director Terry Wright read the report for the record. The current PPS budget as of September 30, 2014, has a balance of \$1,116,054.93; the Education Fund balance is \$68,846.55. As of October 20, 2014, the total registrations for PPS is 18,002, 1,739 licensees, and 595 certifications.

Mr. Bonapart reported that there have been a total of 2,487 various correspondences printed from the PPS database, 4,950 registration cards have been printed and a total of 5,849 applications received since the last Board meeting.

# MOTION BY MR. MACRAE TO ACCEPT THE DIRECTOR'S REPORT; SECONDED BY MR. BOOTH; MOTION CARRIED.

Director Wright advised the board that testing for the computer database upgrade would run through the month of December. Training for industry members would begin in early 2015. He also advised that there is still a balance \$189,000. Department of Public Safety is currently in discussions as to whether they will pay the balance. Director Wright reported that because of the move to DPS, the maintenance for the new system will now cost \$96,000 and the board will need to decide who will absorb the cost.

Mr. MacRae asked if the \$189,000 balance was part of the original contract and if Department of Justice has paid their portion. Director Wright advised they had not.

Mr. Cook asked whether or not Department of Justice has a legal obligation to pay the balance. Director Wright advised that the contract is between the boards and the vendor, not Department of Justice.

Mr. MacRae asked if any of the Department of Justice IT employees transferred and if they would be able to offer support. Director Wright advised that the Department of Public Safety IT employees will be unable to support the system. It was suggested that GL Solutions offer IT support for the first year.

Mr. Booth suggested that the board freeze any new grant money in effort to save money to should the board be responsible for paying the outstanding balance. Mr. MacRae stated that it would not be necessary to freeze any grant money.

Attorney Gray discussed the following:

#### I. CONSENT AGREEMENT, SETTLEMENT AGREEMENTS & CIVIL PENALTIES

- 1. Paul Manley Jr. /Show Pros Entertainment Services of Charlotte, Inc. On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Mr. Manley in the amount of \$15,586.40 in twelve monthly installments for registration violations with the first payment due January 1, 2014. The tenth payment was received on August 1, 2014. (\$1,298.86).
- Scott Smithers/Eye Spy Investigations. On December 12, 2013, the Private Protective Services Board voted to assess a civil penalty in the amount of \$1,000.00 for failing to offer a written report to a client. The Final Agency Decision hearing is scheduled for the Board's October 23<sup>rd</sup> meeting.
- 3. Lance Jones/Safe & Secure Worldwide Protection Group, LLP. On August 21, 2014 the Board voted to enter into a consent agreement with Mr. Jones in the amount of \$1,407.60 for failing to properly register unarmed guards. Payment was due on October 1, 2014. To date, payment has not been received.

#### III. RULES

- The Public Hearing for amendments to 12 NCAC 007D.0105, 0.116,.0809, .1408 and .1508 was held at the board's office 4901 Glenwood Avenue, Suite 200, Raleigh, North Carolina on August 27, 2014 at 2:00 p.m., and the Public Comment Period ended September 30, 2014. A motion to adopt these administrative rule amendments and adoptions is necessary.
- 2. As a part of the transfer to the Department of Public Safety the Board's administrative rules will also have to be amended to reflect this change and transferred to another Title within the North Carolina Administrative Code. There are five (5) references to "Attorney General" in the Board's rules and one (1) reference to "Department of Justice." The Budget Act made all the appropriate changes throughout the General Statutes, including Chapter 114 which governs the Attorney General and the Department of Justice, Chapter 74C which governs Private Protective Services and Chapter 74D which governs Alarm Systems Licensing Board, but the Board will have to go through an "abbreviated" rule amendment process to make the conforming changes to its administrative rules. Notice and a public hearing will not be required, but review by the Rules Review Commission will.

Mr. Gray has been in contact with Molly Masich, Codifier of Rules, who has in turn been in contact with the Rulemaking Coordinator for DPS. Once a new Chapter and numbers are assigned under Title 14B (DPS's section of the Code,) the Board can begin the process.

3. Chapter 93B-2 was amended by the Legislature in House Bill 761, :Regulatory Reform Act of 2014," to add two new requirements to the annual report that the

Board must file with the Secretary of State, Attorney General and the Joint Legislative Administrative Procedures Oversight Committee. In addition to the other 11 items that must be included in the report, the Board must now include: 1). The total number of licensees supervised by the Board, and 2). The number who "failed the examination" (which is generally inapplicable to Private Protective Services except for the examination or Unarmed Guard Trainer and Firearms Trainer certification.)

- 4. The Legislature also amended the rulemaking provisions of Chapter 150B of General Statutes, thereby changing certain requirements of the process for certain proposed rules in G.S. 150B-19.1(h). The requirement for the Governor's cabinet agencies and the departments of Council of State to obtain certification prior to publishing proposed rules is repealed. This was referred to as "G.S. 150B-19.1 Certification." However, certification is still required for proposed rules with substantial economic impact.
- 5. The Legislature also moved the requirement for agencies to obtain Office of State Budget and Management (OSBM) approval of fiscal notes to before publication of the Notice of Text in the North Carolina Register. Furthermore, agencies proposing a rule change with substantial economic impact must obtain a certification form OSBM of adherence to principles (2), (5) and (6) from G.S. 150B-19.1(a) prior to publication. OSBM is drafting new guidelines to include in its State Budget Manual and will circulate it when finalized.

#### **IV. LEGISLATION**

- 1. The General Assembly adjourned for its 2013-2014 Biennial Session with no further action on House Bill 466, "Amend Private Protective Services Act/Fees." Before January 2015, the Board will need to vote on seeking introduction of a similar bill in the 2015-2016 Biennial Session.
- Attorney Gray has previously reported that during the 2012 Session of the Legislature, the Joint Legislative Administrative Procedures Oversight Committee replaced the Joint Select Regulatory Reform Committee. This committee now has oversight over the study by the Program Evaluation Division (PED) of the structure, organization and operation of all occupational licensing boards in the State and the feasibility of a single "umbrella" agency as required by Section 10(a) of S.L. 2013-413. Attorney Gray has been attending the meetings of this Committee.

The PED began the process of evaluation of boards in May, 2014. Only four (4) boards were visited and the staffs interviewed. The remainder is to be evaluated

through a "questionnaire" which all boards, including PPSB, received on July 9<sup>th</sup>. It contained 58 questions, the majority of which were related to financial issues. The responses were submitted by the deadline of July 31<sup>st</sup>. The PED's final report on all occupational and professional licensing boards is due to the Administrative Procedures Oversight Committee by December 31, 2014.

3. On July 10, 2014 Governor Pat McCrory signed Senate Bill 741 (S.L. 2014-67), "An Act to Enhance the Effectiveness of the Occupational Licensing of Military Service Members." This Act amends the recently enacted amendments to Chapter 93B of the General Statutes regarding military-trained applicants and applicants who are spouses of active duty military. (The Board's amendments to its administrative rules to effectuate these requirements were effective October 2, 2013.)

The Act deleted the provision in N.C.G.S. 93B-15.1(a)(1) that the applicant's experience is a determination to be made by the Board. It also requires the Board to notify the military-trained applicant within 30 days following receipt of an application whether the applicant's military training and experience satisfies the requirements for licensure, registration or certification. The Board must publish a document listing the specific requirements for licensure that are satisfied by military training and experience and publish it on the Board's website and the website of the North Carolina Division of Veterans Affairs. The Board must further contact training offices at military installations <u>or</u> any other federal offices that provide information on military occupational specialties and training for the purpose of acquiring information necessary for determining the applicability and correlation of military training and experience to the criteria and requirements for licensure, certification or registration.

No later than September 1, 2014, each occupational licensing board was required to submit a report to the co-chairs of the Legislative Research Commission Study Committee on Civilian Credit for Military Training and State Adjutant Selection Criteria with the status of the required document and the results of their consultation with military training officials as required by the Act.

Similar amendments to this same statute necessitated changes to seven of the Board's administrative rules in October 2013: 12 NCAC 07D .0301 (Experience Requirements for Security Guard and Patrol License), .0302 (Experiences Requirement's for Guard Dog Service License), .0401 (Experience Requirements for Private Investigator License), .0501 (Experience Requirements for Polygraph License), .0601 (Experience Requirements for Psychological Stress Evaluator), .0901 (Experience Requirements for Firearms Trainer Certification), and .0909 (Experience Requirements for Unarmed Trainer Certification.) While each of these rules states that the applicant must "establish to the Board's satisfaction" that the applicant has "two years…verifiable experience," and the latest amendment prevents the Board from making an independent determination of that experience, the current version of these rules still appears to be compliant and no (further) changes should be necessary.

#### V. PENDING CASES

As previously reported, the Plaintiff has refiled the civil action against Board Investigator Sarah Conner, the Board, the City of Charlotte, the Charlotte-Mecklenburg Police Department and various officers of the Charlotte-Mecklenburg PD in *Kelly v. Conner, et al.*, No. 3:13-CV-636 – WDNC. Mr. Kelly was unlicensed as a security guard business and unregistered, but performing security guard and patrol services. He is also a convicted felon. He was arrested and charged with, among other violations, violating Chapter 74C.

The Attorney General's Office is again representing Ms. Conner.

The Board has responded to Plaintiff's First Set of Interrogatories and Request for Production of documents received on May 29, 2014. The Plaintiff was deposed by counsel for the Defendants on October 16<sup>th</sup>, but additional time was needed and his deposition was continued until November 5<sup>th</sup>. It is anticipated that Director Wright and/or Deputy Director Bonapart, and possibly Board member Ron Burris, will be noticed for deposition, as well as Ms. Conner. Attorney Gray plans to file a Motion to Dismiss on behalf of the Board in mid-November once discovery is completed.

The committee meeting was called to order by Richard Epley at 2:04 p.m. on Thursday, December 4, 2014. The purpose of the meeting was to review and consider North Carolina General Statute 74C and the Board's Administrative Rules and propose any necessary changes to either or both.

"It is the duty of every Board member to avoid both conflicts of interest and appearances of conflict. If any member has any known conflict of interest or appearance of conflict with respect to any matter coming to this committee today, please identify the conflict or appearance of conflict and refrain from any deliberation and vote in that particular matter."

Mr. Epley asked committee members if they felt it necessary to reduce the number of members of the Laws and Rules Committee. Mr. Cook stated that the committee should be reduced and offered to step down from the committee. Mr. Foster agreed and also offered to step down. Mr. Booth stated that the issues discussed within the committee require a lot of input and the committee is currently too large to be effective.

# MOTION BY MR. BOOTH TO REDUCE THE LAWS AND RULES COMMITTEE TO FIVE (5) MEMBERS AND ONE CHAIRPERSON; SECONDED BY MR. CESENA; MOTION CARRIED.

#### Proxy Voting

Mr. Epley stated that Mr. Benson wanted to discuss whether Board members should have the ability to vote by proxy. Attorney Gray advised that the PPS Board did not currently have bylaws in place to authorize proxy voting. A proxy vote would require the addition of by-laws. He also stated that the Alarm Systems Licensing Board (ASLB) currently has by-laws.

Mr. MacRae asked Attorney Gray why ASLB has by-laws and PPSB did not and to advise the Board as to the pros and cons of having by-laws. Attorney Gray stated that PPSB likely did not have by-laws because they did not want to be bound by set guidelines, thus giving the Board more flexibility. He also stated that if the committee chose to recommend implementation of by-laws he has a draft copy from years ago when the Board considered adopting them. Mr. MacRae asked Attorney Gray for his recommendation regarding by-laws. Attorney Gray stated that the proxy vote necessitates the addition of by-laws. There is no need to add by-laws if the Board does not desire proxy voting.

# MOTION BY MR. FOSTER NOT TO PERMIT PROXY VOTING OR THE ADDITION OF BY-LAWS; SECONDED BY MR. MACRAE; MOTION CARRIED.

### Virtual Office

The committee members discussed the issue of the virtual office and whether or not it meets the requirements of G.S. 74C. After lengthy discussion it was determined that a separate subcommittee would need to be formed to discuss the matter further.

Mr. MacRae asked Attorney Gray if the virtual office meets the requirements and if an amendment to include the virtual office should be made to 74C. Attorney Gray advised that this would be the time to tweak the statute as technology changes.

Mr. Cesena suggested that Mr. Booth chair the subcommittee.

# MOTION BY MR. FOSTER TO TABLE THE TOPIC OF VIRTUAL OFFICES AND FORM A SUBCOMMITTEE TO FURTHER DISCUSS THE ISSUE; SECONDED BY MR. MACRAE; MOTION CARRIED.

House Bill 466 (Title: Amend Private Protective Services Act/Fees)

Mr. Gray advised that House Bill 466 did not pass in the 2013-2014 session of the General Assembly and that the Board could either re-introduce the identical bill or make some modifications first. He also advised that action will need to be taken at the December Board meeting as we are running out of time. Mr. Epley stated that there were some other issues that he wanted to add to the bill before it was introduced again and the smaller committee size should be able to handle it at the December meeting.

Mr. Bonapart advised that the Laws and Rules Committee would be added to the agenda for Wednesday, December 10<sup>th</sup> at 4:30 p.m. and that a notice will be sent via email.

Mr. Cesena suggested that the issue of armed guards in the schools should go before the House in a completely separate bill and the other members agreed.

Mr. Bonapart advised the committee members of the letter received from Leonard Trent Wolf regarding the requirements for the Guard Dog Profession License.

# MOTION BY MR. COOK TO DESIGNATE COMMITTEE MEMBERS TO CONTACT MR. WOLF TO OBTAIN MORE INFORMATION AS TO HIS REQUEST AND REPORT BACK TO THE FULL BOARD; SECONDED BY MR. CESENA; MOTION CARRIED.

Executive Protection License

Mr. Epley asked the committee members where they stand on the issue of adding an additional, separate license for executive protection providers. Mr. MacRae stated that the Board should not allow industry members to regulate executive protection. Mr. Booth stated that he was not in favor of anymore regulation.

The members discussed whether there would be an actual benefit to separating executive protection from the private investigator license.

Mr. Weaver suggested that this issue be given to the Training and Education Committee to discuss further and report back to the full board.

Mr. Cook asked Mr. Bonapart and Mr. Stephenson if PPS has received any complaints specifically related to executive protection. Mr. Bonapart advised that he has not received any complaints regarding executive protection.

The matter was tabled, no vote was taken.

First Aid /CPR

The committee discussed adding a training requirement of First Aid /CPR for unarmed and armed security guards. Mr. MacRae stated that he strongly advised that the requirement be added. Mr. Foster stated that he would like to see a training requirement of AED and Blood Borne Pathogens added as well.

# MOTION BY MR. BOOTH THAT THE BOARD NOT ADD A FIRST AID/CPR REQUIREMENT TO TRAINING FOR ARMED AND UNARMED SECURITY GUARDS; SECONDED BY COBBLER; OPPOSED BY MR. MACRAE; MOTION CARRIED.

Company Police Holding PPS License

Mr. Epley asked committee members for input as to whether a company police commission holder who is not a sworn law enforcement officer could also be the license holder for a Security Guard and Patrol company. Attorney Gray advised that it is not allowed by G.S. 74C. He also stated that an individual can be the owner, but cannot be the chief and qualifying agent.

#### \$1,000.00 Training Grant

Mr. Cesena suggested to the committee that the board should offer a pre-qualification day to industry members free of charge. The cost would be \$1,000.00. The Board could fund the training via a PPSB training grant. Mr. Booth stated that it was a good suggestion but was more of a Training and Education Committee issue and should be placed on the T & E agenda. The other Board members agreed.

#### Arming PPS Investigators

The committee discussed whether or not the field investigators should be armed. Mr. Cesena stated that he agreed with arming the investigators since they are making visits with individuals who are armed. He also stated that they should be required to qualify with a state issued firearm. Attorney Gray added that their training should fall in line with what is required of the armed security guards.

Mr. Booth asked if arming the investigators is a decision that the Board makes or will it need to be recommended to the Commissioner and Secretary of DPS. Attorney Gray advised that it will require a change in either the Board's enabling statute or elsewhere in the General Statutes and that the Board would have to make the recommendation to DPS.

Mr. Bonapart advised that he would like to set up a meeting with Attorney Gray and the DPS legislative liaisons in order to receive guidance on statute changes and routing the bill through the legislature. The Board members agreed.

No vote was taken.

Jermaine Chareem Norfleet 14 DOJ 05702 (attachment 3). Mr. Norfleet was present. This case was heard by Administrative Law Judge Craig Croom on August 26, 2014. This case involved whether Petitioner should be denied a security guard and patrol license based on Petitioner having violated a written cease and desist letter issued by the Board.

Administrative Law Judge Craig Croom recommends that the denial of Petitioner's application for an armed and unarmed security guard and patrol business license be upheld.

# **DIRECTOR'S REPORT:**

Deputy Director Anthony Bonapart read the report for the record. The current PPS budget as of October 31, 2014, has a balance of \$1,131,685.75; the Education Fund balance is \$69,682.10. As of December 9, 2014, the total registrations for PPS is 16,413, 1,751 licensees, and 597 certifications.

Mr. Bonapart reported that there have been a total of 1,980 various correspondences printed from the PPS database, 2,474 registration cards have been printed and a total of 4,030 applications received since the last Board meeting.

Mr. Bonapart reported that the go live date for the new computer system is January 26, 2015. Mr. MacRae asked if there would be scheduled training for industry members. Mr. Bonapart advised there would be training and the board would be informed when the dates have been determined.

# MOTION BY MR. BOOTH TO ACCEPT THE DIRECTOR'S REPORT; SECONDED BY JUDGE BURRIS; MOTION CARRIED.

### **ATTORNEY'S REPORT:**

Mr. Weaver asked if there was an organizational structure to the Administrative rules and if not could an index be added. Attorney Gray advised that currently there isn't but he could work on adding an index while renumbering the rules. He also advised the board that if they wanted to add the House Bill 466 it would need to be done before 2015.

Mr. MacRae suggested the Laws and Rules committee should have a phone conference to finalize the bill during the last week of the month. Mr. Cook also suggested that the board act on a bill to incorporate security officers on public school property.

Attorney Gray discussed the following:

### I. CONSENT AGREEMENT, SETTLEMENT AGREEMENTS & CIVIL PENALTIES

- 1. Paul Manley Jr. /Show Pros Entertainment Services of Charlotte, Inc. On October 24, 2013 the Private Protective Services Board voted to enter into a consent agreement with Mr. Manley in the amount of \$15,586.40 in twelve monthly installments for registration violations with the first payment due January 1, 2014. The twelfth payment was received on November 26, 2014. (\$1,298.86). Paid in full.
- 2. Scott Smithers/Eye Spy Investigations. On December 12, 2013, the Private Protective Services Board voted to assess a civil penalty in the amount of \$1,000.00 for failing to

offer a written report to a client. Mr. Smithers later declined the consent agreement and requested a hearing before the Office of Administrative Hearings. At the board's October 23<sup>rd</sup> meeting a Final Agency Decision was entered suspending Mr. Smither's license for 6 months. Mr. Smithers was served with the Final Agency Decision on November 6, 2014. His 30 days in which to petition for judicial review expired on December 6<sup>th</sup>.

- 3. Lance Jones/Safe & Secure Worldwide Protection Group, LLP. On August 21, 2014 the Board voted to enter into a consent agreement with Mr. Jones in the amount of \$1,407.60 for failing to properly register unarmed guards. Paid in full.
- 4. Mr. Cleveland Lamar Bridges and American Citadel Guard, Inc. On October 23, 2014 the Private Protective Services Board voted to enter into a consent agreement with Mr. Bridges in the amount of \$7,099.20 for registration violations.
- 5. Mr. Owence Pascal Jean-Baptiste and Centinel Armed Service, LLC. On October 23, 2014 the Private Protective Services Board voted to enter into a consent agreement with Mr. Jean-Baptiste in the amount of \$1,101.60 for registration violations.
- 6. Mr. Joseph Daniel Washington and A1 Tactical Protection Services, LLC. On October 23, 2014 the Private Protective Services Board voted to enter into a consent agreement with Mr. Washington in the amount of \$673.20 for registration violations.
- 7. Mr. Maurice La-Von Hayes and Carolina Security Agency. On October 23, 2014 the Private Protective Services Board voted to enter into a consent agreement with Mr. Hayes in the amount of \$673.20 for registration violations.

#### III. RULES

- The Public Hearing for amendments to 12 NCAC 007D.0105, 0.116,.0809, .1408 and .1508 was held at the board's office 4901 Glenwood Avenue, Suite 200, Raleigh, North Carolina on August 27, 2014 at 2:00 p.m., and the Public Comment Period ended September 30, 2014. The Board adopted these administrative rule amendments at its October 23, 2014 meeting. These rule amendments are calendared for the Rules Review Commission's meeting on December 17, 2014.
- 2. As a part of the transfer to the Department of Public Safety the Board's administrative rules will also have to be amended to reflect this change and transferred to another Title within the North Carolina Administrative Code. There are five (5) references to "Attorney General" in the Board's rules and one (1) reference to "Department of Justice." The Budget Act made all the appropriate changes throughout the General Statutes, including Chapter 114 which governs the Attorney General and the Department of Justice, Chapter 74C which governs Private Protective Services and Chapter 74D which governs Alarm Systems Licensing Board, but the Board will have to go through an "abbreviated" rule amendment process to make the conforming changes to its administrative rules. Notice and a public hearing will not be required, but review by the Rules Review Commission will.

Mr. Gray has been in contact with Molly Masich, Codifier of Rules, and Dana Vojtko, Publications Coordinator, on Monday, December 8<sup>th</sup>. Numbers have now been assigned under Title 14B (DPS's section of the Code) and Mr. Gray will begin the process of reassigning numbers to the Board's rules and making conforming changes within certain rules (i.e. "cross-references.")

### **IV. LEGISLATION**

- The General Assembly adjourned for its 2013-2014 Biennial Session with no further action on House Bill 466, "Amend Private Protective Services Act/Fees." This issue was discussed during the Law and Rules Committee meeting on December 4, 2014. Before January 2015, the Board will need to vote on seeking introduction of the same or a similar bill in the 2015-2016 Biennial Session.
- 2. Attorney Gray has previously reported that during the 2012 Session of the Legislature, the Joint Legislative Administrative Procedures Oversight Committee replaced the Joint Select Regulatory Reform Committee. This committee now has oversight over the study by the Program Evaluation Division (PED) of the structure, organization and operation of all occupational licensing boards in the State and the feasibility of a single "umbrella" agency as required by Section 10(a) of S.L. 2013-413. Attorney Gray has been attending the meetings of this Committee.

The PED began the process of evaluation of boards in May, 2014. Only four (4) boards were visited and the staffs interviewed. The remainder is to be evaluated through a "questionnaire" which all boards, including PPSB, received on July 9<sup>th</sup>. It contained 58 questions, the majority of which were related to financial issues. The responses were submitted by the deadline of July 31<sup>st</sup>. The PED's final report on all occupational and professional licensing boards is due to the Administrative Procedures Oversight Committee by December 31, 2014.

3. On July 10, 2014 Governor Pat McCrory signed Senate Bill 741 (S.L. 2014-67), "An Act to Enhance the Effectiveness of the Occupational Licensing of Military Service Members." This Act amends the recently enacted amendments to Chapter 93B of the General Statutes regarding military-trained applicants and applicants who are spouses of active duty military. (The Board's amendments to its administrative rules to effectuate these requirements were effective October 2, 2013.)

The Act deleted the provision in N.C.G.S. 93B-15.1(a)(1) that the applicant's experience is a determination to be made by the Board. It also requires the Board to notify the military-trained applicant within 30 days following receipt of an application whether the applicant's military training and experience satisfies the requirements for licensure, registration or certification. The Board must publish a document listing the specific requirements for licensure that are satisfied by military training and experience and publish it on the Board's website and the website of the North Carolina Division of Veterans Affairs. The Board must further contact training offices at military installations <u>or</u> any other federal offices that provide information on military occupational specialties and training for the purpose of acquiring information necessary for determining the applicability and correlation of military

training and experience to the criteria and requirements for licensure, certification or registration.

No later than September 1, 2014, each occupational licensing board was required to submit a report to the co-chairs of the Legislative Research Commission Study Committee on Civilian Credit for Military Training and State Adjutant Selection Criteria with the status of the required document and the results of their consultation with military training officials as required by the Act.

Similar amendments to this same statute necessitated changes to seven of the Board's administrative rules in October 2013: 12 NCAC 07D .0301 (Experience Requirements for Security Guard and Patrol License), .0302 (Experiences Requirement's for Guard Dog Service License), .0401 (Experience Requirements for Private Investigator License), .0501 (Experience Requirements for Polygraph License), .0601 (Experience Requirements for Psychological Stress Evaluator), .0901 (Experience Requirements for Firearms Trainer Certification), and .0909 (Experience Requirements for Unarmed Trainer Certification.) While each of these rules states that the applicant must "establish to the Board's satisfaction" that the applicant has "two years…verifiable experience," and the latest amendment prevents the Board from making an independent determination of that experience, the current version of these rules still appears to be compliant and no (further) changes should be necessary.

### V. PENDING CASES

As previously reported, the Plaintiff has refiled the civil action against Board Investigator Sarah Conner, the Board, the City of Charlotte, the Charlotte-Mecklenburg Police Department and various officers of the Charlotte-Mecklenburg PD in *Kelly v. Conner, et al.*, No. 3:13-CV-636 – WDNC. Mr. Kelly was unlicensed as a security guard business and unregistered, but performing security guard and patrol services. He is also a convicted felon. He was arrested and charged with, among other violations, violating Chapter 74C.

The Attorney General's Office is again representing Ms. Conner.

The Board has responded to Plaintiff's First Set of Interrogatories and Request for Production of documents received on May 29, 2014. The Plaintiff was deposed by counsel for the Defendants on October 16<sup>th</sup>, but additional time was needed and his deposition was continued until November 5<sup>th</sup>. Director Wright was deposed on November 21<sup>st</sup>. Two (2) of the CMPD officers and Ms. Conner are to be deposed on December 17<sup>th</sup>. The deadline to complete discovery expires on December 20, 2014.

Mr. Gray, along with the attorneys representing the other Defendants, plan to file motions to dismiss on behalf of our respective clients in mid-December once discover is completed.
