<p><i>Most frequent convicted crime resulting in probation entry was non-trafficking drug offenses (26%), followed by driving while impaired (16%), larceny (14%), and assault (11%). Most parole entries were also non-trafficking drug offenses (13%), followed by driving while impaired (11%), and robbery (10%). The most frequent crime category for post-release supervision entries was non-trafficking drugs offenses (18%), followed by larceny (10%) and breaking and entering (10%).</i></p>
