Call to Order

Chair Tamara Rabenold called the August 15, 2024, meeting of the North Carolina Private Protective Services Board to order at 11:30 a.m.

State Ethics Law

Attorney Jeff Gray read the following statement:

"In accordance with the State Ethics Law, it is the duty of every Board member to avoid both conflicts of interest and appearances of conflict. If any member has any known conflict of interest or appearance of conflict with respect to any matter coming before this Board today, please identify the conflict or appearance of conflict and refrain from deliberation and voting in that matter."

Approval of the June 2024 Board Meeting Minutes

Motion: Debra Duncan motioned to accept the June 20, 2024, Board meeting minutes. Suzanne Creech seconded. The motion carried unanimously.

Committee Reports

Grievance Committee: Grievance Committee members Ron Burris, Tamara Rabenold, Suzanne Creech, Jerry Pitman, Steve Johnson, and Candace Ratliff met on August 14, 2024, from 9:15

a.m. to 1:52 p.m. They heard 23 cases. Committee Chair Ron Burris presented the Grievance Committee report.

<u>Motion:</u> Steve Johnson motioned to accept all cases except 2024-PPS-036 (Juchtman). Kim Heffney seconded. The motion carried unanimously.

<u>Motion:</u> Steve Johnson motioned to accept 2024-PPS-036 (Juchtman). Dave Stephens seconded. The motion carried unanimously. Candace Ratliff recused from the vote.

Mr. Burris explained to the Board that the Grievance Committee would like approval to implement a policy related to follow-up registration compliance audits. Mr. Burris said the Committee recommends that a qualifying agent *not* be required to appear in person at the Grievance Committee if the results of a follow-up audit show a compliance rate of greater than 90% and the qualifying agent agrees with the audit findings.

<u>Motion:</u> Steve Johnson motioned to amend the Board's Follow-Up Registration Compliance Audit policy to implement the Committee's recommendation. Kim Heffney seconded. The motion carried unanimously.

<u>Motion:</u> Dave Stephens motioned to accept the Grievance Committee report. Suzanne Creech seconded. The motion carried unanimously.

Screening Committee: Screening Committee members Dave Stephens, Kim Heffney, Richard Epley, and Assata Buffaloe met on August 14, 2024, from 2:33 p.m. to 4:04 p.m. to review 59 new license applications. Dave Stephens presented the Screening Committee report.

Mr. Stephens said the Screening Committee recommended rescinding the consent agreement for unlicensed activity offered to Vicci Bane in April 2024, as Ms. Bane has since withdrawn her application for a security guard and patrol license.

<u>Motion:</u> Kim Heffney motioned to accept all the Committee's recommendations, except three license applications belonging to Michael Boger. Candace Ratliff seconded. The motion carried unanimously.

<u>Motion:</u> Andy Renfrow motioned to accept the Committee's recommendation for Michael Boger. Jerry Pitman seconded. The motion carried unanimously. Ron Burris recused from the vote.

Laws and Rules Committee: Laws and Rules Committee members Andy Renfrow, Debra Duncan, Steve Johnson, Kim Heffney, and Jerry Pitman met on August 15, 2024, from 10:15 to 10:32 a.m. Committee Chair Steve Johnson presented the Committee report.

Mr. Johnson reminded the Board that amendments to Rules .0701, .0801, .1301, .1401, which will require security guard companies to give guards a copy of their training certificates on or before the first day the guard works a post as a permanent employee, and bring consistency to all the application rules for armed and unarmed security guards and unarmed and unarmed armored car guards, were approved at the June 2024 Board meeting and will be submitted to the Rules Review Commission (RRC) in September 2024. Mr. Johnson also mentioned the pending amendments to Rules .1501 and .1502, as a result of a Board-approved first-aid/CPR/AED provider changing its name. Further, Mr. Johnson said an amendment to Rule .1203, which will remove the 8-hour cap on continuing education for higher-education courses, was approved by the Board in June 2024 and the amendment is proceeding through the rule-amendment process with the RRC.

Director Paul Sherwin discussed a letter he drafted to be sent to the Alarm Systems Licensing Board (ASLB) wherein the PPSB is requesting the ASLB consider amending its statute or administrative rules to allow licensed security guard and patrol companies to monitor surveillance cameras—whether on-site or remotely—belonging to a client for which the security guard and patrol company has a contract for services.

<u>Motion:</u> Suzanne Creech motioned to accept the Law & Rules Report. Candace Ratliff seconded. The motion carried unanimously.

Training and Education Committee: Training and Education Committee members Richard Epley, Steve Johnson, Dave Stephens, Andy Renfrow, and Candace Ratliff met on August 15, 2024, from 9:00 to 9:52 a.m. Committee Chair Dave Stephens presented the Training and Education Committee report, which included updates about completed and planned train-the-trainer courses, and the results of recent compliance audits of two certified trainers.

Mr. Stephens said the Committee reviewed two training grant applications, one from Gabriel McCuller with Sua Sponte Security LLC and another from Laurel Rudd with the International Association of Security and Investigative Regulators (IASIR). Mr. Stephens said the Committee deferred Mr. McCuller's grant application for further consideration and recommended awarding a \$5,000.00 grant to IASIR.

Director Sherwin presented the results of a survey that asked security guard and patrol licensees about the Board's current rules related to the training requirements for probationary unarmed security guards. He said the Board currently requires probationary unarmed security guards to receive at least four hours of training *within* the 20-day probationary period, whereas a majority (approximately 60%) of survey respondents believe probationary unarmed security guards should receive some training *before* working a post. Accordingly, Mr. Stephens said the Training and Education Committee recommends probationary unarmed security guards receive at least four hours of training before working a post and referred the matter to the Laws and Rules Committee for further analysis.

Mr. Stephens said the Board and its staff have received feedback from industry members that the 75-minute unarmed security guard training video is outdated. He said Board staff will research options for updating the video and recommended the Laws and Rules Committee consider

allowing the video to be used as part of the four hours of required training that may be required of probationary unarmed security guards in the future.

Finally, Mr. Stephens reported that the Committee reviewed two applications for new continuing education courses and 26 applications for renewal of an existing continuing education courses. He said the Committee recommended approving all the courses.

<u>Motion:</u> Richard Epley motioned to accept the Training and Education Committee report. Suzanne Creech seconded. The motion carried unanimously.

Emerging Technology Committee: Emerging Technology Committee members Candace Ratliff, Andy Renfrow, and Tamara Rabenold met on August 14, 2024, from 4:15 p.m. to 5:40 p.m. Candace Ratliff presented the Emerging Technology Committee report.

Ms. Ratliff reported that Member Stacy Buff and she attended a virtual roundtable on June 25, 2024, about technology trends in the security industry, which was hosted by IASIR.

Ms. Ratliff said the Committee received an informative and hands-on demonstration from officials with Byrna Technologies, a company that manufactures non-lethal launchers and other self-defense products.

Chair Tamara Rabenold said Director Sherwin and she met recently with ASLB Chair Caroline Brown to discuss how the two Boards can collaborate in the future, to include the possibility of forming a joint committee to address the proposed surveillance camera monitoring amendment to the ASLB's statute and other items.

<u>Motion:</u> Dave Stephens motioned to accept the Emerging Technology Committee report. Suzanne Creech seconded. The motion carried unanimously.

Special Committee on Unlicensed Activity: Suzanne Creech said unlicensed activity continues to be a problem throughout the state and encouraged industry members to report it. In addition, she said Attorney Jeff Gray had prepared a template of charging language that the Board's investigators can use when attempting to obtain an arrest warrant or criminal summons for criminal violations of N.C. Gen. Stat. § 74C.

<u>Motion:</u> Debra Duncan motioned to accept the Special Committee on Unlicensed Activity committee report. Candace Ratliff seconded. The motion carried unanimously.

Special Committee on Continuing Education: Chair Tamara Rabenold presented the Special Committee on Continuing Education Committee report. She recapped a presentation by Timothy Heinle, of the UNC Chapel Hill School of Government (SOG), who previously addressed the Committee about the school's plan to develop an online training platform for civilian investigators.

<u>Motion:</u> Andy Renfrow motioned to accept the Special Committee on Continuing Education Committee report. Dave Stephens seconded. The motion carried unanimously.

Board Elections

Attorney Gray conducted the elections for Board officers and Committee chairs.

Board Chair

Motion: Dave Stephens motioned to nominate Tamara Rabenold for Board Chair. Kim Heffney seconded.

No additional nominations were made.

<u>Motion:</u> Steve Johnson motioned to close nominations and elect Tamara Rabenold as Board Chair by acclamation. Dave Stephens seconded. The motion carried unanimously.

Tamara Rabenold was elected Board Chair.

Board Vice-chair

Motion: Ron Burris motioned to nominate Steve Johnson for Board Vice-chair. Tamara Rabenold seconded.

<u>Motion:</u> Suzanne Creech motioned to nominate Jerry Pitman for Board Vice-chair. Richard Epley seconded.

No additional nominations were made.

Attorney Gray asked for a vote of all in favor of electing Steve Johnson as Board Vice-chair. Seven Board members voted in favor of Mr. Johnson.

Attorney Jeff Gray asked for a vote of all in favor of electing Jerry Pitman as Board Vice-chair. Three members voted in favor of Mr. Pitman.

Steve Johnson was elected Board Vice-chair.

Grievance Committee Chair

Debra Duncan was elected as the Board's liaison to the N.C. Ethics Commission.

Old Business

Chair Rabenold mentioned that the Board's new website was online and complimented its modern design.

New Business

Director Sherwin presented a new proposed Board meeting schedule for 2025. He explained that he would like to try holding ASLB and PPSB meetings during the same week in 2025, which would require the PPSB to move its meetings from even-numbered months to odd-numbered months.

Motion: Richard Epley motioned to accept the new 2025 meeting dates. Suzanne Creech seconded. The motion passed, with Member Jerry Pitman opposed.

Chair Rabenold said the N.C. Association of Private Investigators (NCAPI) is holding its annual conference November 19-20, 2024, in Carolina Beach, and suggested the Board send at least one representative. Members Jerry Pitman, Andy Renfrow and Suzanne Creech volunteered to attend.

<u>Motion:</u> Kim Heffney motioned to send Members Pitman, Renfrow and Creech to the NCAPI Conference. Candace Ratliff seconded. The motion carried unanimously.

Chair Rabenold discussed the possibility of the Board awarding continuing education to those who attend committee meetings that are open to the public, such as Laws and Rules or Training and Education. She suggested this could be discussed further at a future meeting of the Special Committee on Continuing Education.

Director's Report

Director Sherwin presented his Director's Report. The report included information about board staff changes, the status of the board's active licensees, registrants, investigations, and trainers, and an update on board finances.

Director Sherwin also mentioned the following people will attend on behalf of the Board the International Association of Security and Investigative Regulators (IASIR) conference Oct. 9-11, 2024, in Charlotte: Board members Tamara Rabenold, Jerry Pitman, and Andy Renfrow; and Board staff members Bill Raften, Mercedes Sierra, Attorney Jeff Gray, and himself.

Motion: Suzanne Creech motioned to accept the Director's Report. Richard Epley seconded. The motion carried unanimously.

Re: Results of probationary unarmed security guard training survey

At the June 2024 Board meeting, the Board requested staff create and distribute to licensees a survey about whether the training requirements for probationary unarmed security guards should be changed.

North Carolina Gen. Stat. § 74C-11(a) says, "Before a probationary employee engages in private protective services, the employee shall complete any training requirements, and the licensee shall conduct a criminal record check on the employee, *as the Board deems appropriate* [emphasis added]."

In administrative rule 14B NCAC 16 .0707 – Training Requirements for Unarmed Security Guards, the Board defines what training it "deems appropriate" for probationary unarmed security guards: "A minimum of four hours of instruction shall be completed *within 20 calendar days* [emphasis added] of any security guard, including probationary, being placed on a duty station. These four hours shall include the instruction on The Security Officer in North Carolina and Legal Issues for Security Officers."

The survey sought to gather information about whether the survey respondent uses probationary unarmed security guards, and if so, whether the current training requirements should be changed; and offered various response options for how the training requirements could be changed. The survey also allowed for free-text comments, which are included verbatim in this memorandum.

The survey link was distributed to the Board's approximately 3,000 licensees in the June Meeting Hot Sheet, and it was sent again on July 2 to 393 security guard and patrol licensees. The survey received 123 responses. The margin of error for this survey is 7% at a 95% confidence level, based on a population of 393, meaning the results are believed to be accurate for the entire "population" of security guard and patrol licensees at least 95% of the time. For instance, a 60% "yes" response with a 5% margin of error at a 95% confidence level means there is a 95% chance that between 55% and 65% of the population thinks "yes."



In your opinion, if the N.C. PPSB were to amend the unarmed probationary security guard training requirements found in Rule .0707(a), the amendment should:



A total of 60% of respondents said a security guard should receive training *before* working a post:

• 29%: Require the entire 16-hour unarmed security guard course before working a post.

- 20%: Require the 4-hour introductory training before working a post.
- 11%: Require just the 75-minute "Security Officer Training" video, with no additional training, before working a post.

A total of 21% of respondents said the training required within the first 20 days should be changed to:

- 11%: Require just the 75-minute "Security Officer Training" video, with no additional training, within the first 20 calendar days of working a post.
- 10%: Require the entire 16-hour unarmed security guard course within the first 20 calendar days of working a post.

10% of respondents said training requirements for probationary unarmed security guard should be removed.

4% of respondents said "Other" and left the following comments:

- "Require 4 prior to working but change the 16 hour rule, prior to 20 days or 160 hrs of working. No calendar days or"
- "I feel in general Security Officers are not trained enough I am working on a 40 hr course as I feel that the officer needs to have more knowledge of the law to be an effective security officer. I also feel that security should have annual inservice training on legal updates just as LEO does. We as security officer are gradually replacing law enforcement in some areas and we should have the training to reflect such."
- "Probationary should only be used in the event of a State of Emergency. Companies use this after they realize they did not, could not, or forgot to register a Security Officer. Would make better sense to have a form for that reason vs using Probationary. This winds up being a catch all."

5% of respondents did not answer the question.

Finally, the following comments were submitted in response to the survey question, "Is there anything else you would like the Board to consider related to training requirements for probationary unarmed security guards?"

- Too much regulation coming from this Board and the State. Let the general public weed out the incompetent, unprofessional, and uneducated businesses. Good businesses do not need to be told to upgrade, educate, and/or professionalize themselves. We especially do not need some govt hack telling us what's important and what's not.
- Train, train, train. More training is always better than less
- Keep the virtual training classes it works a lot better then in person and maybe allow them to carry OC spray with of course the proper training.

- I understand the thought process of training someone prior to putting someone on post but I believe prior to a company investing into the probationary officer and/or the employee investing into this career path, there should be a trial period to identify if the probationary employee is a good fit for this industry and company. I would also recommend the probationary time be increased to 30 days. This allows companies to track the probationary time more efficiently, and increase the exposure time.
- Nothing.
- I think the only unarmed probationary training needs to be site and position specific OTJ trainings prior to taking a post alone. With the turnover rate in staffing for these many part-time positions these days, the resources spent on trainings before a guard is fully committed and on board with a company can become very costly and time burdensome.
- After the initial four hour training, the guards should attend 16 hour training within the first calendar month.
- I believe there should be a way to register them as probationary instead of reports, that way there is consistency across the board for all new hires.
- N/A
- Leave it alone please. thanks
- No
- I believe there is a way to streamline the background check process, one of the challenges we face is getting people through their background check before working their first post (if their background check is taking more time than anticipated). If there was a conditional background check through a faster service and then the in depth check after the probationary period, it would lessen the upfront expense for employees who may not stay with the company
- Watch the video and within 15 days they scheduled and attend the unarmed Security class
- Yes maybe more education on communication, dealing with the public.
- There are a lot of upfront costs for onboarding an employee that may not even show up on first day. There should be not required training until after a 30 day period. Leave it up to the companies to determine that the guard is qualified to work before any further time is spent.
- I would hope that the company includes LOPs and site-specific training for probationary guards prior to placing them on a post. The first four hours is necessary for liability (if

nothing else!), but an individual should have more information about the client's and the company's expectations, rules, and regulations before working a post for the first time.

- No
- Please update the video. It's so old, (close to 20 I'm guessing) that many parts of it are completely irrelevant. Especially the registration procedures.
- Adopt Virginia and South Carolina and allow private security minimum LEO powers so that we can help take some of the burden off local PD.
- I think armed certifications should last about 2yrs not 1 year this is costing a lot of money all the way around.
- Probationary should only be used in the event of a State of Emergency. Companies use this after they realize they did not, could not, or forgot to register a Security Officer. It would be better to have a form for that reason vs using Probationary. This winds up being a catch-all.
- PPSB might consider a signed acknowledgement that the probationary hires have read the NC PPSB Registration Procedures, certifying that they are eligible for registration, and a signed acknowledgment that they have read and understand certain provisions under 74C that apply to SG&P, with the board standardizing a document that contains the pertinent provisions applicable to a new unarmed guard. the board should focus a significant portion of those regulations on items, conduct, etc. that is prohibited. e.g., being in possession of a firearm while performing guard services, detention, duties of an unarmed guard. A signed acknowledgment prior to performing any duties under the probationary provision gives some comfort that the probationary guard has a base knowledge of strictly prohibited items and conduct, and basic parameters around duties and services. This encourages and ensures that the company has provided a base level of education. a standardized form for signature ensures that every probationary guard is receiving the same information and it is not being left up to the company or the QA to instruct prior to official unarmed training. Regretfully, requiring any amount of training for each new hire by a licensed trainer becomes challenging for a substantial number of SG&P companies who do not have a trainer on staff, and do not have the financial resources to invest in training for each "prospect" hire, not knowing if they are going to work out. On the other hand, simply letting someone walk in off the street and perform regulated services that protect the safety and wellbeing of people and property under a probationary provision creates risk. The middle ground could be a PPSB-endorsed/drafted document for the probationary hire to initial (throughout the document) and sign (in addition to or as an acknowledgment of the 75 min youtube video), to mitigate some of the risk to the hire, the company, and the people and property that are being protected. This twenty probationary period allows us to fulfill our obligation to our customer and then get then get the employee scheduled for their PPSB Certification Class all within the alloted 20 calendar days. As I stated, it works as designed.

Re: Request to amend N.C.G.S. 74D

North Carolina Gen. Stat. § 74D-2 requires a person or firm that monitors or responds to alarm signal devices, burglar alarms, monitored access control, or cameras used to detect burglary, breaking or entering, intrusion, shoplifting, pilferage, theft, or other unauthorized or illegal activity to be licensed by the Alarm Systems Licensing Board. This statutory language, specifically that a person who monitors cameras used to detect unauthorized or illegal activity, was included in the original Alarm Systems Licensing Act of 1983. Today, more than 40 years later, alarm systems technology has undoubtedly changed. Similarly, the way security guard companies prevent, observe, or detect unauthorized activity on private property has also evolved in response to improved technology—namely, cameras.

Security guards and the companies they work for are often asked to monitor camera systems belonging to their clients and respond appropriately to suspicious activity captured by a camera system. This allows one or a small number of security guards to monitor a client's property more effectively and efficiently. Most often, a security guard is monitoring cameras from a control room located within the same property as the camera system. However, there is a growing trend of security companies and their guards being asked to monitor a client's property from off-site and dispatch a security guard in response to suspicious activity observed by the camera system.

Therefore, we, the member of the Private Protective Services Board, request the Alarm Systems Licensing Board consider amending its statute or administrative rules to create an exemption that allows security guard and patrol companies licensed under North Carolina Gen. Stat. § 74C to monitor and act in response to an alert from the cameras or camera systems belonging to a client with which they have a contract for security guard services. The proposed exemption would not allow a licensed security guard and patrol company or its employees to install or service cameras or other alarm system components, but it would allow the for the on-site or off-site monitoring of a client's existing security camera system and response to an alert triggered by such cameras.

Proposed language for the exemption is as follows:

§ 74D-3. Exemptions.

The provisions of this Chapter shall not apply to:

•••

(6) Any person who is licensed or registered under Chapter 74C to provide security guard and patrol services and who, as part of a contract for security guard and patrol services, is required to monitor and respond to alerts from a client's security camera system while in the performance of their duties.

An exemption such as this would be in the spirit of the existing exemption found in Chapter 74C that allows companies licensed under Chapter 74D to provide alarm response services:

§ 74C-3. Private protective services profession defined.

(a) As used in this Chapter, the term "private protective services profession" means and includes the following:

•••

(9) Special limited guard and patrol profession. - Any person who is licensed under Chapter 74D of the General Statutes of North Carolina and provides armed alarm responders pursuant to G.S. 74C-13. Applicants for this limited license shall not be required to meet the experience requirements for a security guard and patrol license. Any experience gained under this limited license shall not be counted as experience for a security guard and patrol license.

Alternatively, knowing how difficult it can be to amend a statute, the Alarm Systems Licensing Board may wish to amend its administrative rule in which the term "monitors" is defined:

14B NCAC 17 .0103 DEFINITIONS

In addition to the definitions under G.S. Chapter 74D, the following definitions shall apply throughout this Chapter:

(11) "Monitors" means receiving a signal from a protected premises or contracting with a person, firm or corporation to provide accessible equipment and personnel to receive a signal from an alarm device in a protected premises and take action in response. <u>The term</u> "monitors" does not apply to any person or firm who is licensed or registered under Chapter 74C to provide security guard and patrol services and who, as part of a contract for security guard and patrol services, is required to monitor and respond to alerts from a client's security camera system while in the performance of their duties.





III. ADMINISTRATIVE RULES

a. At its August 2022 meeting the Board voted to amend its rule governing unarmed guard training to incorporate all current methods of administering classroom training: inperson, in-person remotely, synchronously, or in a hybrid format. The Notice of Text for this one rule amendment was filed, it was posted on the Board's website, and the Public Hearing held. The Public Comment Period ended on December 2, 2022. Evidently, with all the temporary and permanent rules being considered and filed for the new CPP and DFE licenses during this period, this amendment to 14B NCAC 16.0707 "fell through a crack."

At about the same time in mid-November 2023, Director Sherwin <u>and</u> staff of the Office of Administrative Hearings' Rules Division discovered it had never been submitted for a permanent rule.

At its December 14, 2023 meeting I explained my mistake and the Board voted again to approve the amendments so as to start the process over.

The Notice of Text was filed on January 3, 2024. The Public Hearing was Tuesday, February 20, 2024, at 2:00 p.m. at the Board's office and the Public Comment Period ended April 11, 2024. There were written comments which were considered at yesterday's Law & Rules Committee meeting. The Committee voted to remove amended, renumbered .0707(c)(8) in its entirety, and the Board voted to approve it at its April 18, 2024 meeting. I filed the Submission for Permanent Rule form the next day, April 19th. I responded to a few minor Requests for Technical Changes, and these amendments were approved by the Rules Review Commission at its May 29, 2024 meeting. They were effective June 1st.

A copy was attached to my June 19, 2024 Attorney's Report as Attachment 2.

b. For the most part, the administrative rules governing the initial application and license renewal process are identical. These existing rules were used as a template for the CPP and DFE rules. A Staff Attorney for the Rules Review Commission objected to non-substantive wording in numerous instances. This necessitated changes to seven other preexisting rules which were approved by the Law & Rules Committee at its February meeting. Other "clean-up" items were approved at that meeting, as well, including adding first aid training to 14B NCAC 16 .1501 and creating an intern and apprenticeship opportunity for Private Investigators as was created for Digital Forensic Examiners. In the midst of preparing these rule adoption and amendments, Director Sherwin was notified by Permitium that it would be increasing its transaction fee from \$4.00 to \$5.00 effective September 1, 2024. This necessitated a change in 17 (!) rules. I was authorized at the Board's February meeting, as part of the above adoption and amendment, to make these changes.

The Notice of Text for one rule adoption and 29 amendments were filed on March 1, 2024. The Public Hearing was held April 16, 2024, at 2:00 p.m. at the Board's office and the Public Comment Period ended on May 31, 2024. No comments were received, written or oral, however, a related comment was received regarding a name change of a certifying entity which was addressed at the June Law & Rules Committee meeting.

The Board voted to approve these rule amendments and adoption at its June 20, 2024 meeting.

The Submission for Permanent Rule forms for each was submitted on June 29, 2024. I have received some minor comments and questions from a Staff Attorney for the Rules Review Commission, the responses to which are due August 19th.

IV. LITIGATION

At its June 2024 meeting the Board instructed me to seek injunctive relief against Martha C. Chase and Boss Lady Bail Bonds for advertising private investigator services on her website. A Complaint for Injunctive Relief was filed on June 28, 2024 and served by the Onslow County Sherrif's Office on July 8th.

I recently checked the website for Boss Lady Bail Bonds and it is not currently accessible and has a message stating "Maintenance mode is on." I will continue to monitor it.

The Defendant's Answer is due August 19th.

V. LEGISLATION

a. Part I of Senate Bill 41, S.L. 2023-8, "Protect Religious Meeting Places," amends N. C. Gen. Stat. § 14-269.2(2) to define "school operating hours," then amends N. C. Gen. Stat. § 14-269.2 by adding a new subsection, "(k1)," that first excludes property owned by a local board of education or county commission, educational property that is an institution of higher education or a nonpublic post secondary education institution, and property that is posted against carrying a concealed handgun, then allows persons with a concealed handgun permit to carry a handgun on property that is both a school and a building that is a place of religious worship outside of school operating hours.

This bill was vetoed by the Governor but the veto was overridden on March 29, 2023. Part I was effective December 1, 2023.

b. House Bill 47, "School Protection Act," amends N. C. Gen. Stat. § 14-269.2(g), entitled "Weapons on campus or other educational property," to allow armed security guards registered under Chapter 74C to discharge the guard's official duties on the grounds of private church schools and qualified nonpublic schools.

It also unnecessarily amends N. C. Gen. Stat. § 74C-3(a)(6) by creating a new subsection, "f.", to define these guards.

It has been referred to the House Committee on Education K-12.

A copy was attached to my February 16, 2023 Attorney's Report.

c. House Bill 49, "Protect Religious Meeting Places," amends N. C. Gen. Stat. § 14-269.2 by adding two new subsections, (a) (1c) and (k1), and amending N. C. Gen. Stat. § 14-415.27 (i.e. the Concealed Handgun Permit statute) to allow persons with a concealed handgun permit to carry on religious property that is also defined as educational property under certain conditions.

It passed the House on February 16^{th} and has been referred to the Senate Rules Committee.

d. House Bill 101, "The Firearms Liberty Act," makes numerous changes to our State's firearms laws (one of which has already been enacted in a separate bill: repeal of the handgun purchase permit requirement) had a provision similar to HB 49, however it was stricken by Committee Substitute in the House Judiciary Committee. It was re-referred to the House Finance Committee.

e. Senate Bill 343, "Protect Children in Private Schools," amends N. C. Gen. Stat. § 14-269.2(a) to define "administrative director" and "board of trustees" to then allow the administrative director to authorize persons with a concealed handgun permit to carry a "firearm" or a stun gun on educational that is a private school under certain circumstances. It has been referred to the Senate Committee on Rules.

f. I have also been monitoring numerous bills that effect boards and commissions, generally, as well as rulemaking.
