

#### I. CONSENT AGREEMENTS & CIVIL PENALTIES

On May 19, 2022 Mark Alan Lilly and Modern Systems entered into a Consent Agreement in the amount of \$6,528.00 for registration violations. Payment has been received. (PAID IN FULL)

On June 14, 2022 Grady Lee Smith, Jr. and Alarm Pro-Tech, Inc. entered into a Consent Agreement in the amount of \$3,400.00 for registration violations. Payment has been received. (PAID IN FULL)

On June 23, 2022 Julio Cesar Chavez and Appalachian Network Services, Inc. entered into a Consent Agreement in the amount of \$7,905.00 for registration violations. Payment has been received. (PAID IN FULL)

#### II. OFFICE OF ADMINISTRATIVE HEARINGS

#### III. RULES

a. At its September Board meeting I was asked to prepare an amendment to the two rules governing applications (i.e. 14B NCAC 17 .0201, licensees, and 14B NCAC 17 .0301, registrants) to make a deadline for application completion. Also, .0201 was amended to reflect the new process for submitting character references on-line through CRC.com.

These two rules as proposed for amendment were approved at the Board's November 2021 meeting.

The Notice of Text was filed December 15, 2021. The Public Hearing was held Tuesday, February 8, 2022 at 2:00 p.m. at the Board's office. The Public Comment Period expired March 22, 2022. There was no public comment written or oral. A copy of these rule amendments were attached as Attachment 2 to my May 19<sup>th</sup> Attorney's Report. The Board voted to approve these rule amendments at its May 19, 2022 meeting.

The Submission for Permanent Rule forms were filed on May 27, 2022. After responding to Requests for Technical Changes from staff, the Rules Review Commission approved these amendments at its June 16, 2022 meeting.

b. At its November Board meeting I was asked to prepare an amendment to 14B NCAC 17 .0204 regarding renewal and reinstatement of a license to provide for a reinstatement application, a criminal history record check for reinstatement, and other requirements.

The Board voted to approve this rule amendment at its January 20, 2022 Board meeting.

The Notice of Text was filed March 10, 2022. The Public Hearing was held on Tuesday, April 26, 2022 at 2:00 p.m. at the Board's office. The Public Comment Period expired May 31, 2022. There were no comments written or oral. A copy of these rule amendments are attached as Attachment 2.

A vote to approve these rule amendments is in order for today.

#### IV. LEGISLATION

At the request of the Board I prepared a new bill, virtually identical to the proposed bill that was introduced in the last two sessions of the General Assembly, for introduction in the most recent (i.e. 2021-2022) Session. The bill was introduced on May 11, 2021 and was House Bill 933. A copy was attached to my May 20, 2021 Attorney's Report.

A staff attorney from Legislative Analysis, with my assistance, prepared a Proposed Committee Substitute for HB 933 to correct errors made by the Legislative Drafting Division in the introduced version. (A copy of the PCS was attached to my July 22 2022 Attorney's Report.) House Bill 933 was to be heard in the House Finance Committee on Tuesday, June 15<sup>th</sup> but was pulled from the agenda at the last minute because of a concern expressed by a House member, who is also a licensee. Susanna Davis, Legislative Liaison for DPS, attempted on numerous occasons to arrange a meeting with that legislator to address his concern but it never occurred.

There was no action on this bill thereafter and it "died" for all intents and purposes upon adjournment of the legislature on Friday, July 1, 2022.

**CHAPTER 17 - ALARM SYSTEMS LICENSING BOARD** 

SECTION .0200 - PROVISIONS FOR LICENSEES

#### 14B NCAC 17.0204 **RENEWAL OR REINSTATEMENT OF LICENSE**

(a) Each applicant for a license renewal shall submit an online renewal application on the website provided by the Board. This online application shall be submitted not less than 30 days prior to expiration of the applicant's current license and shall be accompanied by:

- (1)statements of the result of a local statewide criminal history records search by the reporting services service designated by the Board pursuant to G.S. 74D-2.1 for any state where the applicant has resided within the preceeding preceding 24 months;
- the applicant's renewal fee as set forth in (2).0203(a)(2); and
- (3) proof of liability insurance pursuant to G.S. 74D-9.

(b) Applications for renewal shall be submitted not less than 30 days before the expiration date of the license. No renewal shall be granted more than 90 days after the date of expiration of a license. (c) Applications for renewal submitted after the expiration date of the license shall be accompanied by the late renewal fee established by Rule .0203 of this Section and shall be submitted not later than 90 days after the expiration date of the license.

(d) If a licensee has maintained a license at least two years and fails to renew the license within 90 days of the expiration date, then allows the license to expire, the license may be re-issued if an online reinstatement application is made submitted within one vear of the expiration date. The reinstatement application must include accompanied by the items required in Subparagraphs (a)(1) through (3) of this Rule, the late fee required by Paragraph (c) of this Rule, evidence of compliance with the electrical

licensing requirements of Rule .0210 of this Section, and documentation of completion within the previous two years of continuing education as required by Section .0500 of this Chapter. If the license reinstatement is approved, the license period shall be prorated to expire on the date the previous license would have expired, had the license been renewed on time. The licensee shall remain responsible for compliance with the Board's law and administrative rules during the period of lapse.

(e) The Director shall review and approve or recommend denial of an application for renewal or reinstatement. All denials shall be submitted to the Board for a final Board decision.

(f) Members of the armed forces whose licenses are in good standing and to whom G.S. 105-249.2 grants an extension of time to file a tax return shall be granted the same extension of time to pay the license renewal fee and to complete the continuing education requirements prescribed in Section .0500 of this Chapter. The Board has different processes for graduates of pharmacy schools who are regulated by the U.S. Department of Education (which have previously been referred to as "accredited" by ACPE) and for graduates of foreign pharmacy schools (which have previously been referred to as "certified" by ACPE). ACPE has announced that, beginning January 1, 2023, it will refer to foreign pharmacy schools as "internationalaccredited." There is no pertinent change in either the ACPE process or the Board's process for either type of school -- merely a terminology change. The current rule defines an "approved school or college of pharmacy" as one "accredited by the American Council on Pharmaceutical Education." The Board proposes to amend the rule to avoid any potential confusion that

might be caused by ACPE's change in terminology. In addition, the rule is proposed for amendment to reflect a change in ACPE's name from "American Council on Pharmaceutical Education" to "Accreditation Council for Pharmacy Education." The actual organization has not changed.

#### **SECTION .1300 - GENERAL DEFINITIONS**

#### 21 NCAC 46 .1317 DEFINITIONS

Terms used in this Chapter and G.S. 90, Article 4A, are defined as follows, unless otherwise defined in G.S. 90, Article 4A:

- (1) Ambulation assistance equipment. Devices that aid in walking, excluding canes, crutches, and walkers.
- (2) Approved school or college of pharmacy. A school or college of pharmacy accredited by the American Accreditation Council for Pharmacy Education on Pharmaceutical Education. ("ACPE") through its PharmD Program Accreditation Standards. It does not include any accreditation, certification or other designation through the ACPE's International Services Program.
- (3) Diagnostic equipment. Equipment used to record physiological information while a person goes about normal daily living or while asleep in order to document a disease process. Early pregnancy tests (EPTs), thermometers,
