JUVENILE JUSTICE REINVESTMENT ACT

Session LAW 2017- 57, Section 16D.4

- SECTION 16D.4.(y) By July 1, 2018, the Administrative Office of the Courts shall expand access to its automated electronic information management system for juvenile courts, JWisE, to include prosecutors and attorneys representing juveniles in juvenile court proceedings. Access shall be limited to examining electronic records related to juvenile delinquency information. Other information contained in JWisE, such as any records pertaining to abuse, neglect, and dependency or termination of parental rights, shall not be made available to a prosecutor or juvenile's attorney through JWisE.
- SECTION 16D.4.(z) Due to the increased mobility of North Carolina citizens across counties, the Administrative Office of the Courts shall develop statewide inquiry access for JWisE users that corresponds to access to juvenile court records as authorized under Chapter 7B of the General Statutes by July 1, 2018.



JWISE (NCAOC) & NC-JOIN (DPS)

- JWis

- NCAOC Web-based application that contains an index of juvenile case information for juvenile abuse, neglect, dependency, termination of parental rights (TPR), emancipation, delinquency, and undisciplined cases

- NC-JOIN

- North Carolina Juvenile Online Information Network
- Web-based system that allows staff in the state's juvenile justice system to track the progress and placement of youth being served by various programs and facilities
- Unique identifier for each juvenile



Project Overview

- Use the NC-JOIN identifier to provide statewide access to delinquency data
- Provide a consolidated view of information pertaining to a juvenile's delinquency data statewide
- Provide access to all district attorneys, assistant district attorneys, public defenders and assigned private attorneys
 - District attorneys and assistant district attorneys will have access to all delinquency information for all offenders
 - Public and private attorneys will have access only to information related to juveniles to whom they are both active and assigned

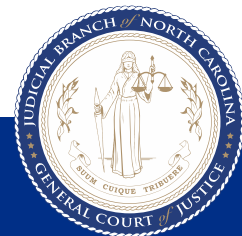
