- SAG is a term that comes from the federal requirement for the federal funds GCC
administer. The federal government just reorganized JJDP Act in December 2018. Went

requirement, with only one or two changes. In North Carolina the SAG is appointed by
executive order from the governor. The last set of two-year terms was done in April
2018. Moving forward, a new executive order will be done to include the JJDP
(Juvenile Justice Delinquent Act) standards by the next committee meeting.
