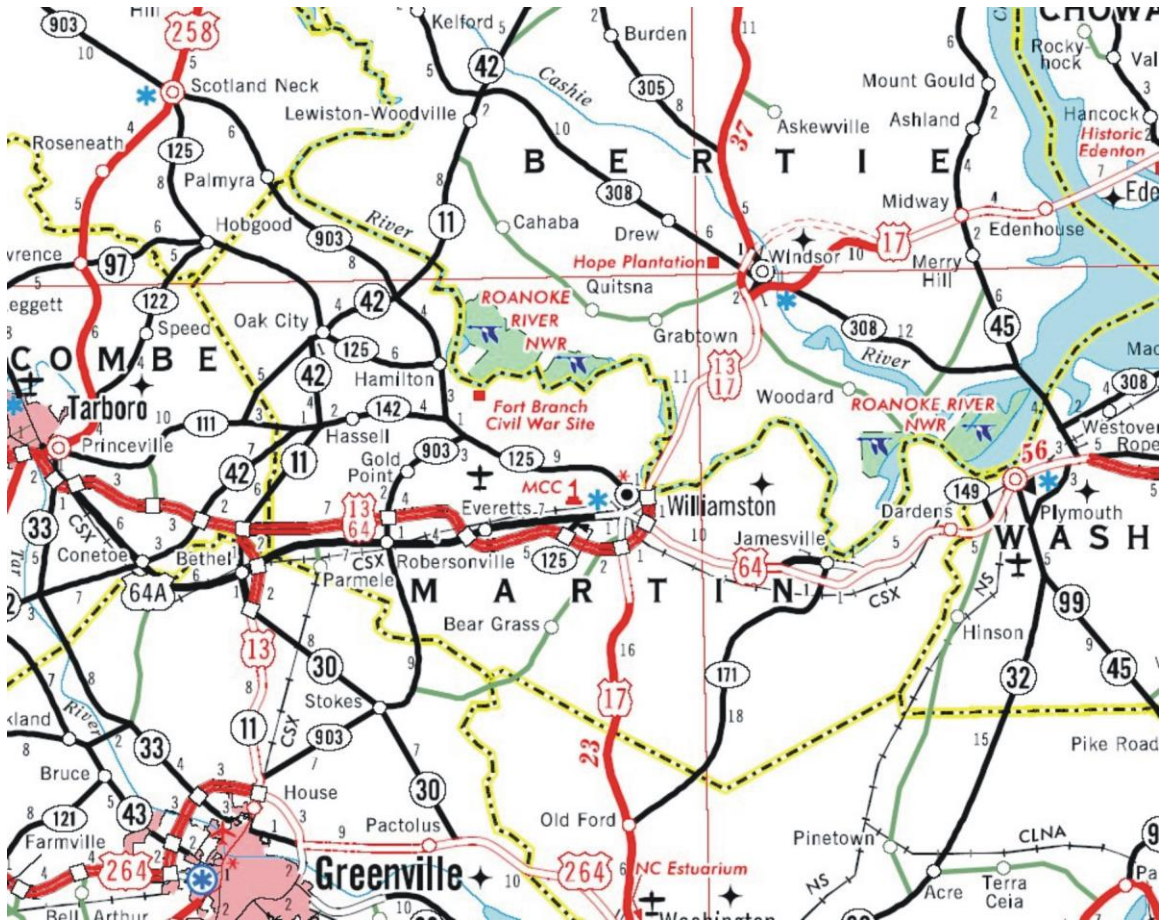

## A-5 Fuel Needs

- Fuel may be obtained at the Troop A District 5 Office.
- In the event power is lost at the District Office, fuel may be obtained at the following locations for each county: Martin – Department of Transportation Facility on NC 125, Williamston on Prison Camp Road.
- In an emergency situation where fuel cannot be obtained at either of the aforementioned locations, fuel may be obtained commercially by using the Voyager Fleet Card, which will be in the possession of a District Supervisor.

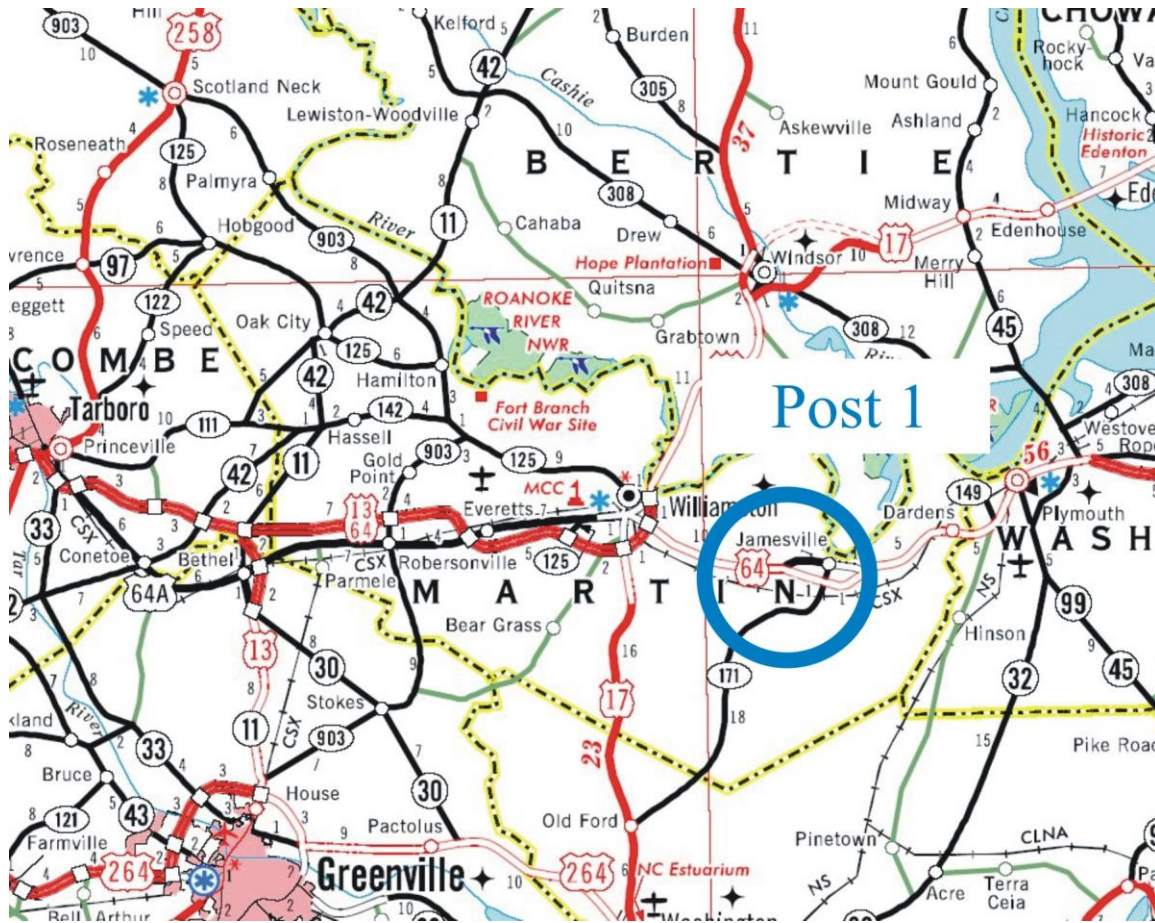

Post 1 – US64 & NC171 – Jamesville (3 Troopers)

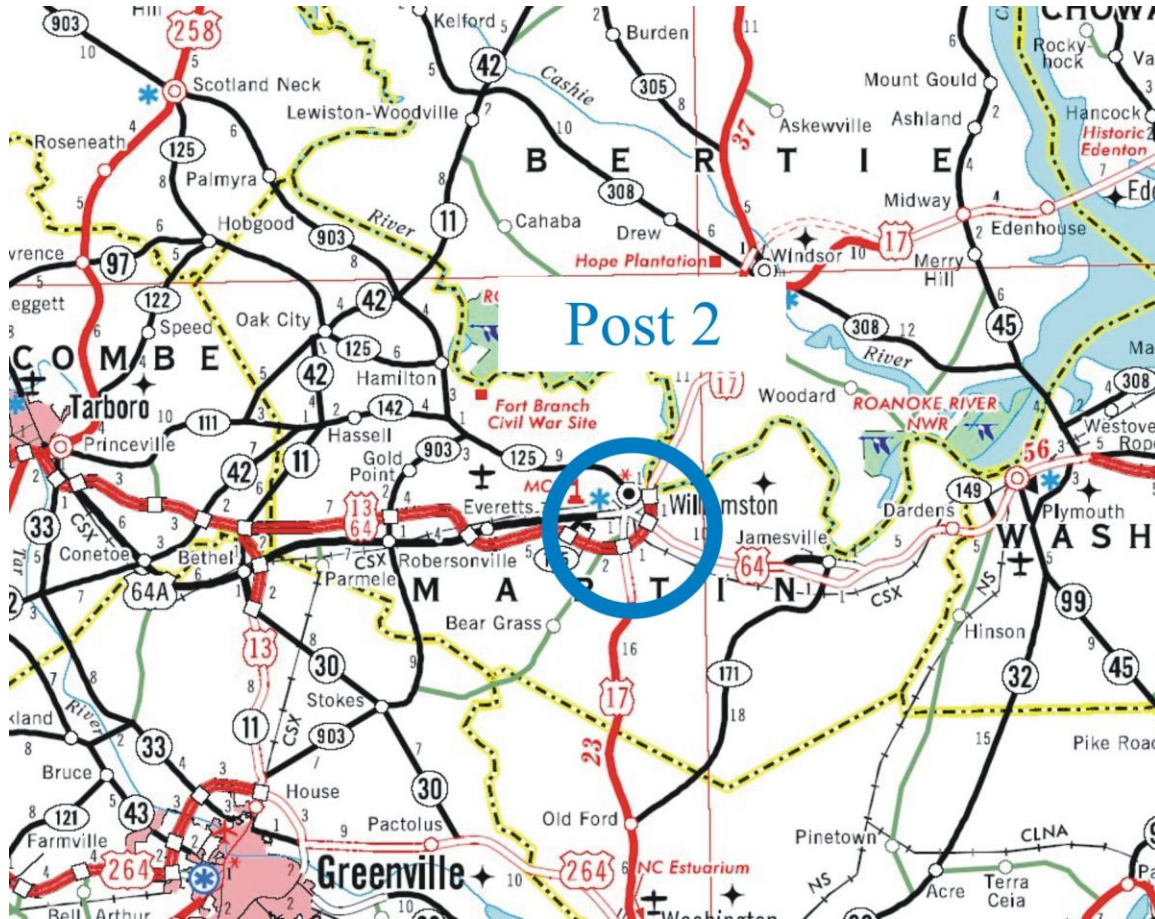
Traffic Light – Direct traffic west on US64

Post 2 – US64 & US17 Business (Exit 515) – Williamston (3 Troopers)

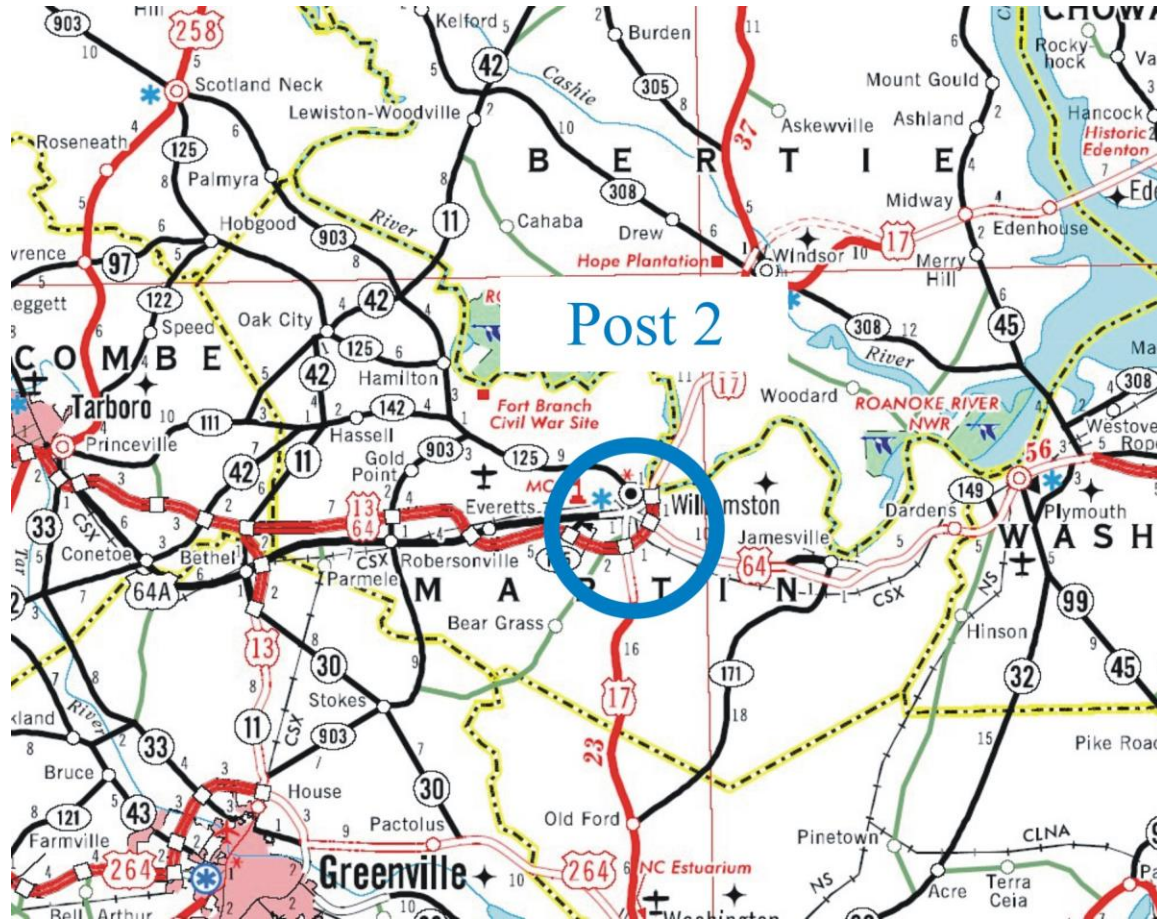
Traffic Lights and Interchange – Personnel will expedite the flow of traffic off US64 onto US17 to avoid a backup onto US64.
