## Domestic Violence Awareness Month

October is Domestic Violence Awareness Month. DVAM was started to raise awareness of the signs of abuse, how to stop it and to provide additional resources to individuals. The Criminal Justice Analysis Center at GCC reported that there were 185,936 partner or family violence incidents reported from 2019-2021. They also found that 21,199 incidents of aggravated assault or homicide were committed by a current or former intimate partner or a family member during the 2019-2021 time period.



Safe Haven of Pender in Burgaw, NC is a domestic violence agency that provides shelter and services to those in Pender and Duplin counties. Safe Haven raised awareness for DVAM by hosting a BBQ fundraiser and The Clothesline Project on Oct. 7. They also hosted a walk and vigil on Oct. 26 to honor victims and survivors of domestic abuse.
