Promoter's Outline

Submit to NC Boxing Commission the following:

- 1. Promoter's application and fee of \$450.
- Surety Bond of \$10,000 must be received 30 days prior to scheduled event or event will be cancelled.
- 3. Event Permit and fee.
 - a. Less than 2000 seats in venue \$150.
 - b. 2000-5000 seats in venue \$300.
 - c. Over 5000 seats in venue \$450.
- 4. Permits must be received 30 days prior to event.
- 5. All fees must be received before a date will be held on the calendar.
- 6. \$2.00 spectator fee will be collected after the show for each person in attendance.

Promoters must ensure that fighters submit the following medicals to the Boxing Commission one week prior to event:

Must be submitted 1 week prior to the event.

- 1. Dilated Eye Exam every 12 months.
- 2. Hepatitis B Surface Antigen every 6 months.
- 3. Hepatitis C Antibody every 6 months.
- 4. HIV every 6 months.
- 5. Doctor's clearance for 24 months of inactivity.
- 6. Fighter's 40 to 45 minimum of but not limited to a doctor's clearance.
- 7. Fighters 45 and above a minimum of but not limited to a doctor's clearance, EKG and Chest X-ray.

Officials will be assigned by the Boxing Commission:

- 1. Officials must be ABC Certified.
- 2. Officials will be assigned who live closest to Venue whenever possible.
- 3. Judges receive \$100 for amateurs and \$125 for pro plus mileage.

- 4. Referees receive \$150 for amateurs, \$175 for pros plus mileage and announcers are \$150.
- 5. Mileage is calculated by state rate of \$.58 for the first 100 miles then \$.30 for the remainder of miles.
- 6. Hotel room must be furnished by promoter if official is 1 hour and a half away from home.
- 7. Announcer and Timekeeper does not have to be assigned but can be assigned if needed (Please indicate on event permit).

Boxing and MMA cards:

- 1. Boxing cards must be submitted to the Boxing Commission for approval, at least 3 weeks prior to the event.
- 2. Email to ncboxingcommission@gmail.com.
- 3. MMA cards must be entered at least 3 weeks prior to the event on the MMA registry at https://www.mmareg.com for approval.

Physician and Ambulance:

1. Physicians

- a. Must be licensed as a MD in North Carolina (PA's not acceptable).
- b. Must conduct pre-bout exam of each fighter.
- c. Must remain at ringside during all bouts.
- d. If physician is needed to attend to injured fighter in dressing area, bout in ring must stop until physician returns to ringside.
- e. Must conduct post-bout exam of each fighter.

2. Ambulance

- a. Must remain on site for the duration of all bouts.
- b. Must have at least 2 attendants.
- c. Must have portable defibrillator.
- d. Must have canister of oxygen with equipment necessary to operate.
- e. Must have stretcher and clean blankets.
- f. Must have back board.
- g. Must have leg and arm splints.
- h. Must have neck brace.

Barrier

- 1. A crowd control barrier must be installed at least 8 feet away from ring. This barrier must be capable of restraining spectators from entry to the ringside area.
- 2. An aisle must be left clear for contestants and medical personnel to enter the ring.
- 3. Only match officials are allowed to sit at ringside.
- 4. No alcoholic beverages are allowed at ringside.

Misc.

- 1. Water for fighters and officials.
- 2. Ice for corners and dressing rooms.
- 3. Gauge and tape for hand wraps.
- 4. Red and blue tape to distinguish corners.
- Read all rules in Administrative Code paying close attention to section 14A NCAC 12.0404
 Promoters Duties and Responsibilities.

Insurance

- 1. Promoters must have at least \$2,500 of medical coverage for each fighter.
- 2. Promoter is responsible for deductible.
